A W A R D

1. We have heard Mr. Mullapudi Rambabu, learned counsel appearing for the petitioners, assisted by Mr. Praveen Kumar Sharma, Adv. and Mr. Rajesh Kumar Gupta, learned counsel appearing for the respondents. We have also heard learned counsel appearing for APSRTC. Mr. Nitin Kumar, Assistant Manager of Insurance Company is also present.

2. This is a case where the deceased was run over by a bus belonging to APSRTC. The deceased was 46 years at the relevant point of time and said to be doing the business in agro products. He was the sole bread winner of the family and had five dependents.

3. After some discussion with a positive attitude, the Insurance Company represented by Mr. Nitin Kumar, Assistant Manager, and learned counsel for the parties have arrived at a settlement, as per which a total amount of Rs. 25,00,000/- (Rupees Twenty Five Lakhs) will be paid to the legal heirs of the deceased with 7.5% interest, as directed in the MACT Award, within a period of 45 days from today. All other claims which the Insurance Company may have against the APSRTC are kept open.

4. The Special Leave Petition is disposed of in terms of the settlement arrived at between the parties.

5. Pending interlocutory application(s), if any, is/are disposed of.
