Pursuant to the provisions of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Emrock Energy Private Limited, a Subsidiary in which company is holding 50.49%, we wish to inform that, as a part of the Company's strategic business expansion initiative, the Board of Directors of the Emrock Energy Private Limited, the Subsidiary Company, at its meeting held on today has approved to installed a new Bio CNG project.

The proposed project intends to create following yearly production capacity:

- **Production of Bio CNG 1600 Tons and;**
- **Production of FOM [Fermented Organic Manure] 8652.80 Tons and;**
- **Production LFOM [Liquid Fermented Organic Manure 14732.80 Tons**

The total initial estimated cost of project is expected to be in the range of ₹ 30 Crores to ₹33 Crores and same shall be funded by infusing new capital and Financial assistance with Banks or Financial Institution.

The project is expected to be **completed on or before June 30, 2027**, subject to receipt of necessary statutory approvals and completion of construction activities.
