2. Having considered the matters in their entirety and going through the material on record, we do not find any infirmity in the impugned order passed by the High Court.

3. Accordingly, the Special Leave Petitions stand dismissed.

However, in view of the common order dated 06.06.2025 passed in Cases No.05 of 2021 and 11 of 2022 by the Commissioner, Employees Compensation Act, Circle-II, Faridabad, whatever amount which has been deposited by the petitioner, be disbursed to the claimants. The remaining dues against the petitioner in terms of the above order of the Commissioner, Employees Compensation Act, Circle-II, Faridabad, be cleared within four weeks and shall be transferred directly into the bank account(s) of the claimants.
