UPON hearing the counsel the Court made the following
O R D E R

Special Leave to Appeal (C) No(s). 10173/2026

1. Ms. Madhavi Divan, learned senior counsel appearing on behalf of the petitioner submits that an amount of Rs. 2.41 crores, as part of the decree has already been deposited. She would further state that balance of Rs 8.8 lakhs will be deposited within two weeks from today before the Executing Court.

2. In view of the deposit of, virtually the entire decretal amount, learned senior counsel submits that she has instructions to withdraw the Special Leave Petition with a request to lift the attachment order dated 11.02.2026 whereby petitioner's Bank Account No. 916020049567377 maintained with Axis Bank, Green Park, New

Delhi Branch is freezed.

3. In view of the fact that the substantial amount has already been deposited and the petitioner is willing to pay the balance amount, we are of the opinion that interest of justice will be subserved if we set aside the order of attachment dated 11.02.2026. Ordered accordingly. The balance amount shall be deposited within two weeks from today.

4. With these directions, the Special Leave Petition stands disposed of keeping the question of law raised by the learned senior counsel open for being considered in an appropriate case.
