Subject: Clarification regarding Revised Filing of Financial Results, Corrected Independent Auditor's Report and Submission of Declaration under Regulation 33(3)(d) of SEBI (LODR) Regulations, 2015

Dear Sir/Madam,

With reference to the above-mentioned matter and the discrepancy observed in connection with the filing of the Audited Financial Results for the year ended March 31, 2026, we wish to submit the following clarification.

The Statutory Auditors of the Company have issued an **Audit Report with an Unmodified Opinion** on the Audited Financial Results for the financial year ended March 31, 2026. The financial results were duly approved and timely submitted to the Exchange on May 30, 2026.

However, due to an inadvertent clerical error in the filing process, the word "**Qualified**" was mistakenly mentioned in one template header with respect to the audit opinion in the documents uploaded on the Exchange portal. Accordingly, the Company has re-filed the financial results along with the corrected Independent Auditor's Report reflecting the correct audit opinion.


Further, due to an inadvertent clerical oversight during the compilation of the final PDF documents for uploading on the Exchange portal, the Declaration pursuant to Regulation 33(3)(d) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, confirming the issuance of an Audit Report with an Unmodified Opinion, was inadvertently omitted from the original filing and therefore was not attached to the submission made to the Exchange.

We hereby clarify that there is **no change whatsoever in the financial results, financial statements, audit findings, or any other disclosures** submitted earlier. The revised filing is limited solely to:

1. Correction of the audit opinion description from "Qualified" to "Unmodified"; and
2. Submission of the Declaration pursuant to Regulation 33(3)(d), which was inadvertently omitted from the original filing.

In view of the above, we kindly request the Exchange to take on record and consider the revised filing of the financial results along with the corrected Independent Auditor's Report and the enclosed Declaration under Regulation 33(3) (d) of the SEBI (LODR) Regulations, 2015.

We sincerely apologize for these unintentional errors and omissions and assure you that they were purely clerical in nature and were not deliberate. There was no intention to misrepresent any information or to withhold any disclosure from the Exchange or stakeholders.
