**ORDER**

1. Application, for oral hearing, is rejected.
2. Petitioner seeks review of the order dated February 2, 2026 in SLP (C) No.35996/2025.
3. We have perused the application seeking review of the said order, whereby the suit and the cross-objection were directed to be heard by the relevant court at Gurugram.
4. According to the petitioner, no part of the cause of action has arisen within Haryana so as to clothe the court at Gurugram with jurisdiction.
5. We find from the plaint that purchase order was issued by

the respondent no.1 from Gurugram. Payment too was made by the respondent no.1 to the petitioner from Gurugram. This also appears from paragraph 5 of the review petition.

6. This is sufficient to clothe the civil court at Gurugram with jurisdiction.

7. No case for review, in our considered opinion, has been set up.

8. The review petition is, therefore, dismissed.
