This is further to our disclosures dated 30th January 2026, 15th July 2026 and 18th August 2026 regarding investment by Exide Industries Limited ("Company") by way of subscription in the equity share capital of its wholly owned subsidiary, "Exide Energy Solutions Limited" (hereinafter referred as 'EESL').

In this connection, we wish to inform you that the Company on 29th September 2026, has invested Rs. 99,99,99,980/- (Rupees Ninety-Nine Crore Ninety-Nine Lakh Ninety-Nine Thousand Nine Hundred Eighty only) by way of subscription in the equity share capital EESL, on rights basis. With this investment, the total investment made by the Company in EESL stands to Rs. 5,202.23 crore. There is no change in the shareholding percentage of the Company in EESL pursuant to such an acquisition.

Some of the relevant details of EESL are given below: - Paid up equity share capital as on date: Rs. 1,618.50 crore - Net worth as on 31.03.2026: Rs. 3,991.06 crore - Turnover as on 31.03.2026: Rs. 157.56 crore - Loss after Tax for the year ended 31.03.2026: Rs. 248.16 crore As on date, the total investment by Exide Industries Limited in the equity share capital of EESL including share premium stands to Rs. 5,202.23 crore including investment made in erstwhile merged subsidiary Exide Energy Private Limited ('EEPL').
