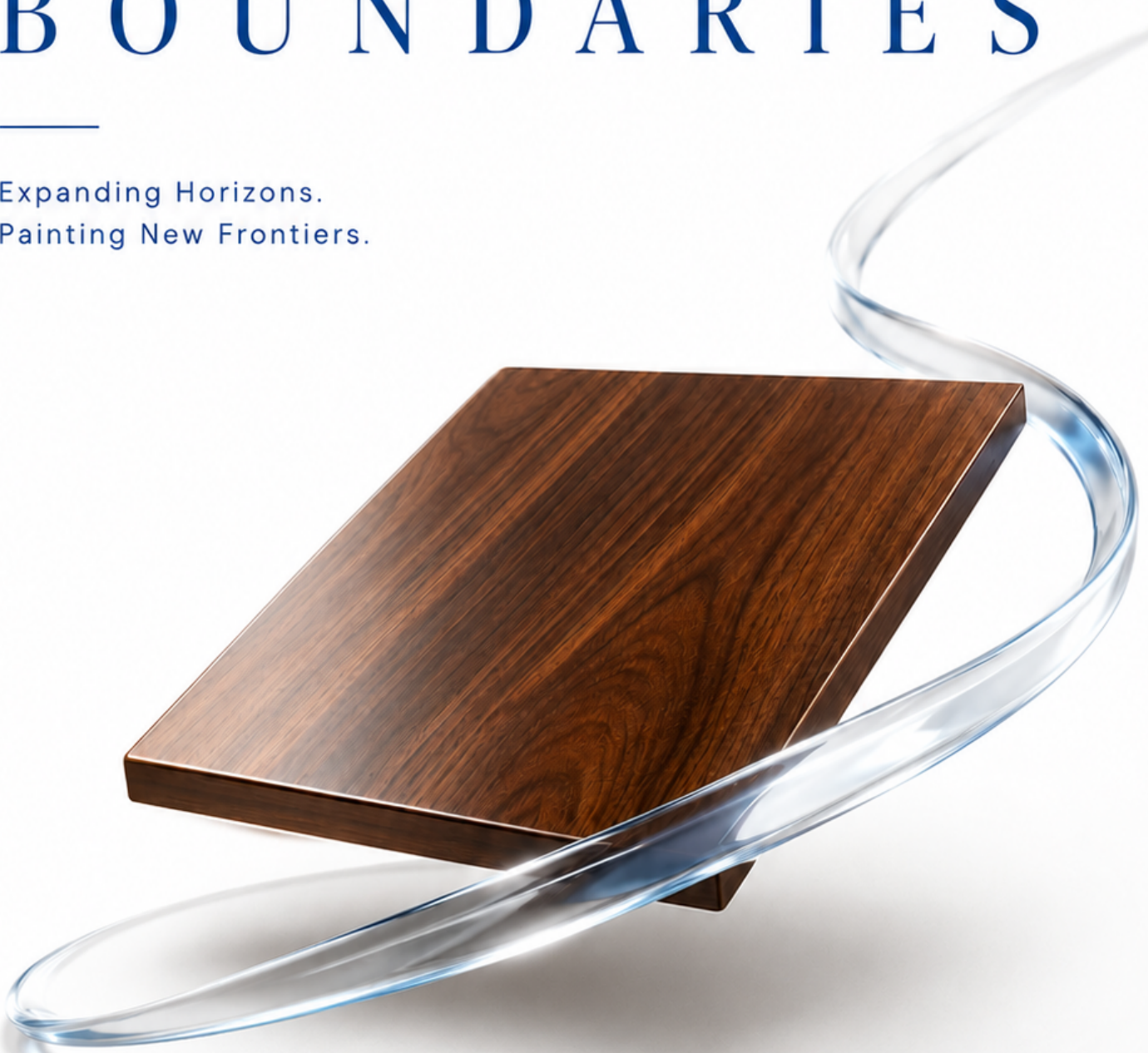

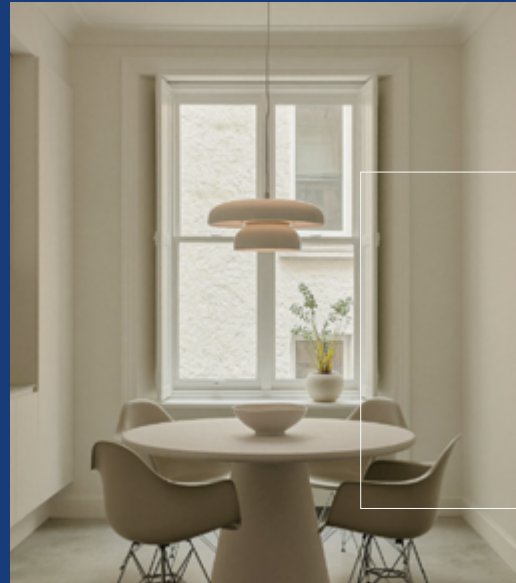

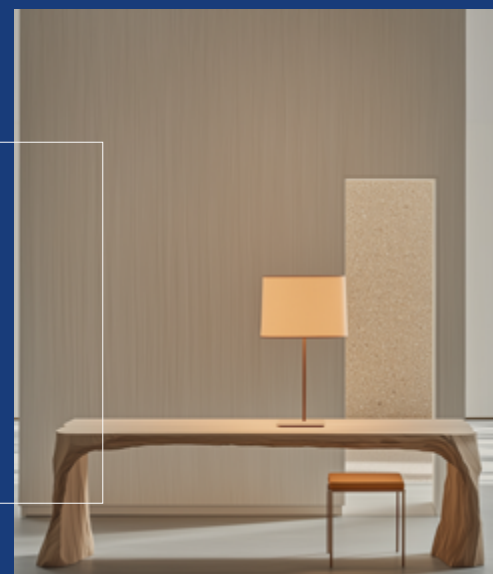

FY 2025-26 marked a defining chapter in Sirca Paints India Limited's growth journey as the Company successfully translated its acquisition-led strategy into accelerated business performance. The integration of the Wembley and Welcome brands strengthened Sirca's position across the entire coatings value chain, enabling the Company to serve customers from economy to luxury segments through a diversified multi-brand portfolio.

The operationalization of the dedicated Wembley manufacturing facility enhanced production capabilities, improved supply-chain efficiencies, and unlocked significant cross-distribution synergies. Simultaneously, the launch of Valentino expanded Sirca's presence in the fast-growing mass-premium polyurethane coatings segment, bridging the gap between premium and mid-market offerings.

Supported by deeper penetration across Tier-2 and Tier-3 markets, an expanding dealer network, and stronger OEM relationships, Sirca delivered revenue growth of 31.79%, reaching ₹492.48 crore during FY26, significantly outperforming broader industry growth trends.

The upgraded Sirca Parivaar Pro platform connected more than 25,000 contractors nationwide, creating a digitally enabled ecosystem that strengthens engagement, loyalty, and knowledge sharing across the value chain. 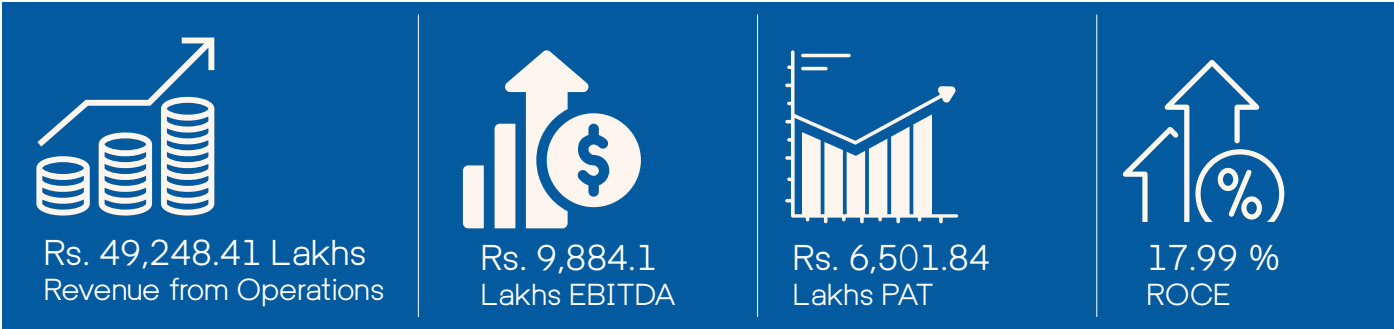
The Path Forward: Driving Sustainable Growth

Dear Shareholders,

It gives me great pride to address you at the close of FY26 — a year in which Sirca Paints India Limited delivered its strongest performance to date, even as the broader paints industry navigated a challenging demand environment. While the major industry players grew revenues in the low to mid single digits (3–6%) in FY26, Sirca grew revenues by 31.79% to ₹492.48 crore, EBITDA by 46.62% to ₹98.88 crore, and Profit After Tax by 32.48% to ₹65.05 crore. The Board has recommended a final dividend of ₹2 per share, reflecting our confidence and commitment to your trust.

These results did not happen by accident. They are the outcome of a deliberate strategy built on premium positioning, Italian-technology backed innovation, and a deepening pan-India distribution network.

The Wood Coatings Industry: Moderate Near-Term, Powerful Long-Term

India's wood coatings market — valued at approximately USD 700 million in 2024 — is on a firm structural growth path, projected to expand at a CAGR of over 10% through 2030. The demand environment in FY26 remained moderate in pockets, shaped by unorganised competition and consumer sentiment softness in certain geographies. Yet the long-term tailwinds are unmistakable and accelerating.

India's furniture market, valued at USD 25 billion in 2025 and projected to reach USD 40 billion by 2031, is increasingly shifting toward organised, branded, and factory-finished formats — with wood commanding nearly 60% of material share. The expansion of retailers like IKEA, Godrej Interio, and Pepperfry, alongside the rapid scaling of modular kitchens and wardrobes, is driving consistent demand for high-performance coating systems. The PM Awas Yojana-led housing boom and the surge in premium residential and commercial construction are further fuelling demand for quality interior wood finishes — from doors and panels to cabinetry and flooring.

Technology, too, is evolving decisively. **Acrylic coatings** are the fastest-growing segment within premium wood finishes, preferred for their non-yellowing properties, low-VOC formulations, and superior aesthetics. **Waterborne and UV-cured systems** are gaining rapid traction, supported by growing environmental awareness and regulatory compliance requirements. Simultaneously, the formalisation of India's furniture manufacturing ecosystem including BIS quality mandates is rewarding organised, compliant players and creating a more level competitive field. These trends align precisely with Sirca's portfolio direction and product philosophy.

A Transformational Year for Sirca

FY2025-26 was more than a strong financial year — it was a year of strategic transformation. The **acquisition of the Wembley brand**, established in 1961 and trusted for over six decades for its NC sealers, lacquers, enamels, and thinners, was the defining move of the year. With the new dedicated Wembley manufacturing facility now fully operational, we have **extended our portfolio** from **super-luxury Italian finishes** all the way to the **mass and mid-premium** market — enabling Sirca to address the entire wood coatings spectrum. The cross-distribution synergies between Sirca's nationwide premium network and Wembley's deep North India footprint represent a compelling growth engine for the years ahead.

On technology, we made significant progress on our **Italian formula transfer** initiative for acrylic and polyester systems, a move that will strengthen localisation, improve cost economics, and deepen our manufacturing integration. The **Wembley Valentino** brand — our luxury PU wood finishes range — was successfully launched, and we are evaluating **export opportunities**, particularly in polyurethane-based coatings, to begin building international channel partnerships.

Our **distribution network** expanded meaningfully during FY26, with continued Tier-2 and Tier-3 city penetration through new branches,

depots, dealer appointments, and Sirca Studios. The upgraded **Sirca Parivaar Pro loyalty** platform now counts **25,000+ contractors registered** with over **20,000 average daily product scans**, creating a digitally-connected ecosystem that drives brand loyalty across the channel. Our engagement with architects and designers reached new heights — including the Sirca Specialista Iceland Expedition for 60 architect couples, participation at India Wood Bangalore, and strategic editorial partnerships with Architectural Digest and Elle Decor.

Looking Ahead

As I look to FY27, I do so with conviction. The structural tailwinds — urbanisation, the housing cycle, premiumisation of consumer preferences, organised furniture growth, and the deepening influence of design professionals — are all compounding. We enter the new year with a broader portfolio, stronger manufacturing, wider distribution, and a clearer **strategic identity as India's most aspirational, multi-brand coatings platform**. Our OEM relationships with 900+ clients, including Godrej, Space Wood, MAS Furniture, and Jindal Stainless, remain a key strategic pillar as India's modular furniture and institutional markets continue to scale.

I want to close by expressing my sincere gratitude — to you, our shareholders, for the confidence you place in us; to our 800+ team members who bring this vision to life with passion and precision; and to our principal Sirca S.p.A. in Italy, whose global technology and decades of innovation continue to be the foundation of our competitive advantage. FY26 has set a new benchmark. We are ready to build on it.

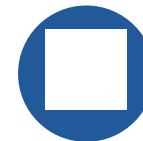

Sirca Founded in Italy - The Durante Group

The Sirca brand is established in Italy under the Durante Group, specialising in premium wood coatings. The brand rapidly earns recognition for its Italian craftsmanship, technical precision, and superior formulations - building a legacy that would eventually travel the world.



1973–2000

Global Expansion - 85+ Countries

Sirca S.p.A. Italy expands its footprint across 85+ countries worldwide, with two state-of-the-art production plants and over 800 employees. Over 20% of its workforce is dedicated to technical and R&D roles, cementing Sirca's position at the frontier of wood coatings innovation.

Early 2000s

Sirca Enters India as Exclusive Licensee

Sirca S.p.A. Italy enters the Indian market through an exclusive licensee arrangement, bringing Italian wood coatings expertise to India for the first time. The company began importing Polyurethane Polish (PU) products from Italy - the foundational product that would define the Indian business. India becomes Sirca's most significant international market.



Early 2000s

First to Launch Wood Filler in India

The India entity achieves a product milestone - becoming the first company to launch wood filler in India. It also opened wholly owned branches in Mumbai and Chennai, establishing an early pan-India physical presence and signalling its ambition to go beyond the northern market.

2006–2015

Building the North India Leadership Position

Through the 2000s and early 2010s, the company established dominant market leadership in premium wood coatings across North India. Revenue grew from ₹29 crore (FY12) to ₹65 crore (FY15), with expanding relationships with prestigious OEM clients including JSL Lifestyle, Spacewood, Alsorg Interiors, and Magpie.



2017

Name Change - Sirca Paints India Private Limited

The company's name was changed to 'Sirca Paints India Private Limited' on 3rd May 2017, aligning the corporate identity more closely with the internationally recognised Sirca brand. This prepares the ground for the public listing that would follow.



2018

Conversion to Public Limited Company

The company converts from a private limited to a public limited company and is rechristened 'Sirca Paints India Limited' on 17th January 2018 - marking the beginning of its transition from a closely held enterprise to a publicly accountable, capital-market-oriented business.

2018

IPO - Listed on NSE SME Emerge Platform

Sirca Paints India Limited launches its Initial Public Offering (IPO) with a price band of ₹160 per share. Bidding runs from 16th–22nd May 2018, and the shares are listed on the NSE SME Emerge platform on 30th May 2018. The IPO raises ₹77.91 crore - capital deployed 100% towards stated objectives. This listing transforms Sirca from a private enterprise into a publicly accountable, investor-facing company.



2018–2020

Manufacturing Scale-Up - Sonipat Facility

Sirca establishes and expands its state-of-the-art manufacturing plant at Sonipat, Haryana - a milestone that marks the transition from a pure importer-distributor to a manufacturer. The Sonipat facility begins production of melamine, NC products, and economical PU, while a separate wall paints and putty facility is established in the NCR region.



2021

Migration to NSE & BSE Main Board

After three years of strong performance on NSE SME, Sirca Paints migrates to the NSE and BSE Main Board - a defining step that expands its investor base, increases liquidity, and elevates governance standards. The BSE Scrip Code 543686 is assigned. Sirca now trades on India's two premier exchanges, accessible to all categories of investors including institutional funds.



2021–2022

Resin Manufacturing Line & D'Aqua PU Launch

Sirca commissions an in-house resin manufacturing line at the Sonipat facility - a significant step toward backward integration and raw material cost control. The company also launches 'D'Aqua PU', a new water-based coatings range that strengthens its eco-friendly product credentials and opens access to the growing sustainable coatings segment.

2023

Bonus Issue - 1:1 Share Allotment

The Board of Directors approves and allots 2,74,04,400 bonus equity shares on 12th May 2023 in the ratio of 1:1 - effectively doubling the number of shares in circulation, rewarding shareholders and improving stock liquidity.

FY23-24

Oikos Partnership - Premium Italian Eco-Finishes

Sirca enters an exclusive distribution agreement with Oikos S.p.A., a prestigious Italian brand renowned for eco-friendly decorative and solid colour finishes. The partnership also includes a future provision for in-India manufacturing of five high-value Oikos products - Ultrasaten, Supercolor, Rasokol, Il Primer, and BLANKOR - products with A+ air quality certification, leveraging Oikos's presence in 80+ countries.

FY24-25

Landmark Acquisition - Wembley Group & Welcome Brand

Sirca completes the transformational acquisition of the Wembley Group along with the Welcome brand from New Wembley Products LLP. The acquisition expands Sirca's portfolio to include enamels, thinners, wall paints, and specialty coatings - fundamentally changing the character of the business from a premium wood coatings specialist to a full-surface solutions company.

FY25-26

Sirca extended its Italy agreement to 2041 with technology transfer for local manufacturing and launched the Valentino PU sub-brand under Wembley.

Management Discussion & Analysis

MACROECONOMIC LANDSCAPE

The global economy remained resilient during FY 2025-26 despite geopolitical uncertainties, evolving trade dynamics, and fluctuations in commodity prices. According to the International Monetary Fund (IMF), global GDP growth is estimated at approximately 3.1% in 2026, supported by easing inflationary pressures, stable consumer demand, and continued investments in infrastructure and technology. While growth across major economies remained uneven, sectors linked to housing, renovation, and interior aesthetics continued to witness healthy demand.

The paints and coatings industry benefited from rising urbanization, increasing renovation activity, and growing consumer preference for premium and sustainable products. However, volatility in crude oil and petrochemical derivatives continued to influence raw material costs across the industry. Despite these challenges, long-term demand drivers such as residential construction, premium home improvement, and luxury interior finishes remained intact, supporting growth opportunities for decorative paints and wood coatings manufacturers.

For the speciality wood coatings industry, the global macroeconomic backdrop in FY 2025-26 translated into a series of tailwinds and headwinds. The global wood coatings market was estimated at approximately 3.54 million tonnes in 2026, growing at a CAGR of over 3.61% during 2026-2031. Asia-Pacific continued to dominate global wood coatings consumption, accounting for approximately 56.68% of global market volume in 2025, driven by the region's position as the world's largest furniture manufacturing and export hub. Polyurethane resins held the leading position in the resin-type segment with a 60.14% share, while waterborne systems emerged as the fastest growing technology segment, driven by tightening environmental regulations.

INDIAN ECONOMY

India continued to be one of the fastest-growing major economies during FY 2025-26, supported by strong domestic consumption, rising infrastructure investments, expanding manufacturing activity, and sustained urbanization. As per the National Statistical Office (NSO), India's real GDP growth is estimated at around 7.4% for FY 2025-26, significantly outperforming many global economies.

The government's continued focus on infrastructure development, housing, smart cities, and urban modernization has created a favorable environment for

the construction and real estate sectors. Rising disposable incomes, increasing home ownership, and changing consumer preferences have accelerated spending on home décor, modular furniture, premium interiors, and renovation activities.

These trends have directly supported demand for decorative paints, wood coatings, texture finishes, and premium surface solutions. The ongoing shift towards premiumization, coupled with shorter repainting cycles and growing awareness of aesthetic and durable finishes, continues to drive growth in the organized paints industry. Given its strong portfolio comprising Sirca, Unico, Oikos, and Welcome, the Company remains well positioned to capitalize on the growing demand for premium wood coatings, decorative paints, and interior finishing solutions across India.

INDUSTRY OVERVIEW: PAINTS & COATINGS



Indian Paints Industry

India continued to be one of the fastest-growing paint markets globally during 2025, supported by sustained urbanization, rising disposable incomes, premium housing demand, increasing renovation activity, and strong government investments in infrastructure.

The decorative paints segment remains the largest contributor to industry revenues, accounting for nearly three-fourths of the market, with demand driven by residential housing, repainting cycles, home improvement, and premium interior finishes.

The Indian market also witnessed heightened competitive intensity with new capacity additions and aggressive market expansion by leading players. Despite pricing pressures and slower urban demand during parts of 2025, long-term fundamentals remain supported by favourable demographics, increasing housing stock, and a shift toward premium products.

Wood Coatings Industry Trend

The global wood coatings industry continued to benefit from increasing demand for premium furniture, modular kitchens, engineered wood products, flooring, cabinetry, hospitality projects, and luxury residential developments.

Consumer preferences are shifting toward environmentally friendly, water-based, UV-curable, and low-emission wood coatings that provide enhanced durability, scratch resistance, colour retention, and superior surface aesthetics. Manufacturers are also investing in faster curing technologies and high-performance polyurethane systems to improve efficiency and finish quality.

Asia-Pacific remains the largest regional market due to expanding residential construction, increasing furniture production, and growing disposable incomes.

To support this growth, the Company plans a capex of ₹5–6 crore in FY27 towards acrylic manufacturing capacity expansion and continued localization of acrylic and UV coatings.

Growth will be driven by the pan-India expansion of the Wembley and Valentino brands through Sirca's distribution network, deeper penetration in western and southern India, and increased presence in Tier II and Tier III cities through new depots, dealer additions, and Sirca Studios. The Company also aims to strengthen its OEM and institutional business, while initiating exports under the Wembley and Valentino brands, targeting a 3–4% contribution to revenue. Under the arrangement, Sirca S.p.A. will transfer technical know-how for the manufacture of high-quality, high-technology acrylic, UV and polyester-based wood coating products in India, which were previously imported.

The technology transfer will enable the Company to indigenize the production of high-quality, high-technology coatings, enhance manufacturing capabilities, improve product offerings, and reduce dependence on imports. The initiative is expected to provide greater operational efficiency through better inventory management, improved working capital utilization, enhanced supply chain flexibility, and stronger market competitiveness. This collaboration reflects the Company's continued commitment towards technology absorption, adoption of advanced manufacturing processes, and innovation-led growth.

ii. Benefits derived as a result of the above efforts, e.g. product improvement, cost reduction, product development, import substitution etc.

This strategic initiative will allow the Company to cut down on its import bill and inventory days of finished goods, increase its manufacturing in India, and strengthen its operations.

Report on the Audit of the Standalone Financial Statements

Opinion

We have audited the accompanying standalone financial statements of Sirca Paints India Limited (“the Company”), which comprise the standalone balance sheet as at March 31, 2026, the standalone statement of profit and loss (including other comprehensive income), the standalone statement of changes in equity and the standalone statement of Cash Flows for the year ended on that date, and the notes to the standalone financial statements including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as “the standalone financial statements”).

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements give the information required by the Companies Act, 2013 (“the Act”) in the manner so required and give a true and fair view in conformity with the accounting standards prescribed under section 133 of the Act read with the Companies(Indian Accounting Standards) Rules 2015, as amended,(“Ind AS”) and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2026 and its profit, other comprehensive income, changes in equity and its cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit of the standalone financial statements in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act. Our responsibilities under those SAs are further described in the Auditor’s Responsibilities for the Audit of the Standalone Financial Statements section of our report. Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial statements of the current period. These matters were addressed in the context of our audit of the standalone financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

a) Revenue recognition (refer note no. 2.4 & 28 of the Standalone financial Statements)

The timing of revenue recognition is relevant to the reported performance of the Company. The management considers revenue as a key measure for evaluation of performance. There is a risk of revenue being recorded before control is transferred.	Assessing the appropriateness of the Company’s revenue recognition accounting policies in line with Ind AS 115 (“Revenue from Contracts with Customers”) and testing thereof. Our audit procedures also included verification of appropriate authorization, analytical review including comparison of budgeted amount and actual charge for the year and review of historical trends in respect of these liabilities.

The Company’s management and Board of Directors are responsible for the preparation of the other information. The other information comprises the information included in the company’s annual report, but does not include The consolidated financial statements, the standalone financial statements and our auditor’s reports thereon.

Our opinion on the standalone financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the standalone financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the standalone financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

NOTES

Note 1: Corporate Information

SIRCA PAINTS INDIA LIMITED (Formerly known as SIRCA PAINTS INDIA PRIVATE LIMITED and earlier known as Sircolor Wood Coatings Private Limited, is a public limited company domiciled in India and incorporated under the provisions of The Companies Act, 1956/2013 located at G-82, Kirti Nagar, Delhi-110015 (India). The Company is listed on the National Stock Exchange (NSE).The company is engaged in the business of sole import and distribution of total product range of Sirca S.P.A. Italy, which has progressively grown up to a significant position in the wood, glass and metal coatings in the global market, becoming one of the four top companies in this segment. Sirca paints india ltd also started its production of wall paints, Melamine products, N.C products and economical P.U. products in technical collaboration with Sirca spa italy that sets the company in the market with particular quality and competitiveness power. Our product range includes all PU products, stains, special effects, acrylic PU, polyester, Wallpaints, U.V. Products etc.

Note 2: Significant accounting policies

The significant accounting policies applied by the Company in preparation of its financial statements are listed below. Such accounting policies have been applied consistently to all the periods presented in these financial statements and in preparing the opening Ind AS financial statement for financial position as at April 1, 2018.

2.1 Statement of compliance

The financial statements have been prepared in accordance with Ind ASs notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time . Upto the year ended March 31, 2019, the Company prepared its financial statements in accordance with the requirements of previous GAAP, which includes Standards notified under the Companies (Accounting Standards) Rules, 2006. These are Company's first Ind AS financial statements. The date of transition to Ind AS is April 1, 2018.

2.2 Basis of Preparation and Measurement

(i) Basis of preparation

The financial statements have been prepared on accrual and going concern basis. The accounting policies are applied consistently to all the periods presented in the financial statements. All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Companies Act, 2013.

Based on the nature of products and the time between acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as 12 months for the purpose of current or non-current classification of assets and liabilities. The financial statements are represented in INR, the functional currency of the Company. Items included in the financial statements of the Company are recorded using the currency of the primary economic environment in which the Company operates (the 'functional currency'). Transactions and balances with values below the rounding off norm adopted by the Company have been reflected as "0" in the relevant notes to these financial statements. The financial statements of the Company for the year ended March 31, 2026 were approved for issue in accordance with the resolution of the Board of Directors on May 7, 2026.

(ii) Basis of measurement

The financial statements have been prepared under the historical cost convention with the exception of certain assets and liabilities that are required to be carried at fair values by Ind AS. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

2.3 Use of estimates and judgment

The preparation of the financial statements in conformity with Ind AS requires management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from those estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. Significant judgments and estimates relating to the carrying values of assets and liabilities include useful lives of property, plant and equipment and intangible assets, impairment of property, plant and equipment, intangible assets and investments, provision for employee benefits and other provisions, recoverability of deferred tax assets, commitments and contingencies.

2.4 Revenue from contract with customers

Company has adopted Ind AS 115 "Revenue from Contract With Customers" starting April 01, 2018. Revenue from contract with customers is recognised when the Company satisfies performance obligation by transferring promised goods and services to the customer. Performance obligations are satisfied at a point of time. Performance obligations are said to be satisfied at a point of time when the customer obtains controls of the asset.

Revenue is measured based on transaction price, which is the fair value of the consideration received or receivable, stated net of discounts, returns and Goods and Service Tax. Transaction price is recognised based on the price specified in the contract, net of the estimated sales incentives/ discounts. Accumulated experience is used to estimate and provide for the discounts/ right of return, using the expected value method. Revenue is only recognised to the extent that it is highly probable a significant reversal will not occur. Our customers have the contractual right to return goods only when authorised by the Company. An estimate is made of goods that will be returned and a liability is recognised for this amount using a best estimate based on accumulated experience.

Income from services rendered is recognised based on agreements/arrangements with the customers as the service is performed and there are no unfulfilled obligations. Interest income is recognised using the effective interest rate (EIR) method.

2.5 Foreign currency transactions and translation

The financial statements of the Company is presented in INR, which is the functional currency of the Company and the presentation currency for the financial statements. In preparing the financial statements of the Company, transactions in currencies other than the entity's functional currency are recorded at the rates of exchange prevailing on the date of the transaction. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at the end of the reporting period. Non-monetary items that are measured in terms of historical cost in a foreign currency are not translated. Exchange differences arising on the settlement of monetary items, and on retranslation of monetary items are included in the statement of profit and loss for the period.

2.6 Property, plant and equipment

An item of property, plant and equipment is recognised as an asset if it is probable that future economic benefits associated with the item will flow to the Company and its cost can be measured reliably. This recognition principle is applied to the costs incurred initially to acquire an item of property, plant and equipment and also to costs incurred subsequently to add to, replace part of, or service it. All other repair and maintenance costs, including regular servicing, are recognised in the statement of profit and loss as incurred. When a replacement occurs, the carrying amount of the replaced part is de-recognised. Property, plant and equipment are stated at cost, less accumulated depreciation and impairment. Cost includes all direct costs and expenditures incurred to bring the asset to its working condition and location for its intended use. Trial run expenses (net of revenue) are capitalised. Borrowing costs during the period of construction are added to the cost of eligible tangible assets.

Gain or loss arising on disposal of an asset is determined as the difference between the sale proceeds and the carrying amount of the asset, and is recognised in the statement of profit and loss.

Property, plant and equipment which are not ready for intended use as on the date of Balance Sheet are closed as "Capital work-in-progress".

Advances paid towards the acquisition of property, plant and equipment outstanding at each balance sheet date is classified as capital advances under "Other Non-Current Assets".

2.7 Intangible assets

Patents, trademarks, License and software costs are included in the balance sheet as intangible assets where they are clearly linked to long term economic benefits for the Company. In this case they are measured initially at purchase cost and then subsequently intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses, if any.

The useful lives of intangible assets are assessed as either finite or indefinite. Finite-life intangible assets are amortised on a straight-line basis over the period of their estimated useful lives. Estimated useful lives by major class of finite-life intangible assets are as follows:

Design - 10 years

Know-how - NIL

Computer software - 5 years

Trademarks - 5 years

The amortisation period and the amortisation method for finite-life intangible assets is reviewed at each financial year end and adjusted prospectively, if appropriate. For indefinite life intangible assets, the assessment of indefinite life is reviewed annually to determine whether it continues, if not, it is impaired or changed prospectively basis revised estimates.

2.8 Depreciation and amortization of property, plant and equipment

Depreciation is the systematic allocation of the depreciable amount of an asset over its useful life and is provided on written down value basis over the useful life as prescribed in Schedule II of the Companies Act, 2013 unless otherwise specified. Depreciable amount for the assets is the cost of an asset less its estimated residual value. Depreciation on addition to/deductions from fixed assets is provided on pro rata basis from/to the date of acquisition/disposal. Depreciation on assets under construction commences only when the assets are ready for their intended use.

2.9 Financial Instruments

I. Financial Assets:

Financial assets are recognised when the Company becomes a party to the contractual provisions of the instrument.

On initial recognition, a financial asset is recognised at fair value. In case of Financial assets which are recognised at fair value through profit and loss (FVTPL), its transaction cost is recognised in the statement of profit and loss. In other cases, the transaction cost is attributed to the acquisition value of the financial asset.

Financial assets are subsequently classified and measured at

- amortised cost

- fair value through profit and loss (FVTPL)

- fair value through other comprehensive income (FVOCI).

Financial assets are not reclassified subsequent to their recognition, except during the period the Company changes its business model for managing financial assets.

(a) Trade Receivables and Loans:

Trade receivables are initially recognised at fair value. Subsequently, these assets are held at amortised cost, using the effective interest rate (EIR) method net of any expected credit losses. The EIR is the rate that discounts estimated future cash income through the expected life of financial instrument.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial instrument and of allocating interest income or expense over the relevant period. The effective interest rate is the rate that exactly discounts future cash receipts or payments through the expected life of the financial instrument, or where appropriate, a shorter period.

(b) Debt Instruments:

Debt instruments are initially measured at amortised cost, fair value through other comprehensive income ('FVOCI') or fair value through profit or loss ('FVTPL') till derecognition on the basis of (i) the Company's business model for managing the financial assets and (ii) the contractual cash flow characteristics of the financial asset.

Financial assets at amortised cost(AC)

Financial assets that are held within a business model whose objective is to hold financial assets in order to collect contractual cash flows that are solely payments of principal and interest, are subsequently measured at amortised cost using the 'EIR' method less impairment, if any. The amortisation of EIR and loss arising from impairment, if any is recognised in the Statement of Profit and Loss.

Financial assets measured at fair value through Other Comprehensive Income (FVOCI)

Financial assets that are held within a business model whose objective is achieved by both, selling financial assets and collecting contractual cash flows that are solely payments of principal and interest, are subsequently measured at fair value through other comprehensive income. Fair value movements are recognised in the other comprehensive income (OCI). Interest income measured using the EIR method and impairment losses, if any are recognised in the Statement of Profit and Loss. On derecognition, cumulative gain or loss previously recognised in OCI is reclassified from the equity to 'other income' in the Statement of Profit and Loss.

Financial assets measured at fair value through Other Profit or Loss (FVTPL)

A financial asset not classified as either amortised cost or FVOCI, is classified as FVTPL. Such financial assets are measured at fair value with all changes in fair value, including interest income and dividend income if any, recognised as 'other income' in the Statement of Profit and Loss.

(c) Equity Instruments

All investments in equity instruments classified under financial assets are initially measured at fair value, the Company may, on initial recognition, irrevocably elect to measure the same either at FVOCI or FVTPL.

The Company makes such election on an instrument-by instrument basis. Fair value changes on an equity instrument is recognised as 'other income' in the Statement of Profit and Loss unless the Company has elected to measure such instrument at FVOCI. Fair value changes excluding dividends, on an equity instrument measured at FVOCI are recognised in OCI. Amounts recognised in OCI are not subsequently reclassified to the Statement of Profit and Loss. Dividend income on the investments in equity instruments are recognised as 'other income' in the Statement of Profit and Loss.

(d) Derivative Financial Instruments

The Company uses derivative financial instruments to hedge its foreign currency and commodity risks. Derivatives are measured at fair value. The treatment of changes in the value of derivative depends on their use as explained below:

Cash Flow Hedges:

Derivatives are held to hedge the uncertainty in timing or amount of future forecast cash flows. Such derivatives are classified as being part of cash flow hedge relationships. For an effective hedge, gains and losses from changes in the fair value of derivatives are recognised in other comprehensive income. Any ineffective elements of the hedge are recognised in the statement of profit and loss. If the hedged cash flow relates to a non-financial asset, the amount accumulated in equity is subsequently included within the carrying value of that asset. For other cash flow hedges, amounts accumulated in other comprehensive income are taken to the statement of profit and loss at the same time as the related cash flow.

Derivatives for which hedge accounting is not applied

Derivative financial instruments for which hedge accounting is not applied are initially recognised at fair value on the date on which a derivative contract is entered and are subsequently measured at FVTPL.

Impairment of financial assets

The Company applies expected credit loss (ECL) model for measurement and recognition of loss allowance on the following:

- Trade receivables
- Financial assets measured at amortised cost (other than trade receivables)
- Financial assets measured at fair value through other comprehensive income (FVTOCI).

In case of trade receivables, the Company follows a simplified approach wherein an amount equal to lifetime ECL is measured and recognised as loss allowance. In case of other assets (listed as ii and iii above), the Company determines if there has been a significant increase in credit risk of the financial asset since initial recognition. If the credit risk of such assets has not increased significantly, an amount equal to 12-month ECL is measured and recognised as loss allowance. However, if credit risk has increased significantly, an amount equal to lifetime ECL is measured and recognised as loss allowance. Subsequently, if the credit quality of the financial asset improves such that there is no longer a significant increase in credit risk since initial recognition, the Company reverts to recognising impairment loss allowance based on 12-month ECL. ECL is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the Company expects to receive (i.e. all cash shortfalls), discounted at the original effective interest rate.

Lifetime ECL are the expected credit losses resulting from all possible default events over the expected life of a financial asset. 12-month ECL are a portion of the lifetime ECL which result from default events that are possible within 12 months from the reporting date. ECL are measured in a manner that they reflect unbiased and probability weighted amounts determined by a range of outcomes, taking into account the time value of money and other reasonable information available as a result of past events, current conditions and forecasts of future economic conditions. As a practical expedient, the Company uses a provision matrix to measure lifetime ECL on its portfolio of trade receivables.

The provision matrix is prepared based on historically observed default rates over the expected life of trade receivables and is adjusted for forward-looking estimates. At each reporting date, the historically observed default rates and changes in the forward-looking estimates are updated.

ECL allowance recognised (or reversed) during the period is recognised as income/expense in the Statement of Profit and Loss under the head 'Other expenses'. conditions and forecasts of future economic conditions.

Derecognition of financial assets

The Company derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or it transfers the financial asset and substantially all risks and rewards of ownership of the asset to another entity. If the Company neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Company recognises its retained interest in the assets and an associated liability for amounts it may have to pay. If the Company retains substantially all the risks and rewards of ownership of a transferred financial asset, the Company continues to recognise the financial asset and also recognises a collateralised borrowing of the proceeds received.

II. Financial liabilities and equity instruments

Classification as debt or equity

Financial liabilities and equity instruments issued by the Company are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of the Company after deducting all of its liabilities. Equity instruments are recorded at the proceeds received, net of direct issue costs.

Financial Liabilities

Initial Recognition and measurement

Financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument. Financial liabilities are initially measured at the amortised cost unless at initial recognition, they are classified as fair value through profit and loss. In case of trade payables, they are initially recognised at fair value and subsequently, these liabilities are held at amortised cost, using the effective interest rate method.

Subsequent measurement

Financial liabilities are subsequently measured at amortised cost using the EIR method. Financial liabilities carried at fair value through profit or loss are measured at fair value with all changes in fair value recognised in the Statement of Profit and Loss.

Derecognition of financial liabilities

The Company derecognises financial liabilities when, and only when, the Company's obligations are discharged, cancelled or they expire.

2.10 Employee benefits

Defined contribution plans

Contributions to defined contribution schemes such as employees' state insurance, labour welfare fund etc. are charged as an expense based on the amount of contribution required to be made as and when services are rendered by the employees.

Company in respect of above schemes has made contribution to a Government administered fund(s) and charged as an expense to the Statement of Profit and Loss. The above benefits are classified as Defined Contribution Schemes as the Company has no further defined obligations beyond the monthly contributions.

Defined benefit plans

For defined benefit retirement schemes, the cost of providing benefits is determined using the Projected Unit Credit Method, with actuarial valuation being carried out at each balance sheet date. Re-measurement gains and losses of the net defined benefit liability / (asset) are recognised immediately in Other Comprehensive Income.

The service cost, net interest on the net defined benefit liability / (asset) is treated as a net expense within employment costs.

Past service cost is recognised as an expense, when the plan amendment or curtailment occurs, or when any related restructuring cost or termination benefits are recognised, whichever is earlier.

The retirement benefit obligation recognised in the balance sheet represents the present value of the defined-benefit obligation, as reduced by the fair value plan assets.

2.11 Inventories

Inventories are valued at the lower of cost and net realisable value. Cost is computed on a weighted average basis. Cost of finished goods and work-in-progress include all costs of purchases, conversion costs and other costs incurred in bringing the inventories to their present location and condition. The net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and estimated costs necessary to make the sale.

2.12 Provisions and contingent liability

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance Sheet date. If the effect of the time value of money is material, provisions are discounted to reflect its present value using a current pre-tax rate that reflects the current market assessments of the time value of money and the risks specific to the obligation. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

2.13 Income taxes

Tax expense for the year comprises current and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from net profit as reported in the statement of profit and loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible.

The Company's liability for current tax is calculated using tax rates and tax laws enacted in the country. It is recognised in the Statement of Profit and Loss except to the extent it relates to an item which is recognised directly in equity or in other comprehensive income.

Interest expenses and penalties, if any, related to income tax are included in finance cost and other expenses respectively. Interest Income, if any, related to Income tax is included in Other Income.

Deferred tax is recognised in respect of temporary differences between the carrying amount of assets and liabilities for financial reporting purposes and the corresponding amounts used for taxation purposes.

A deferred tax liability is recognised based on the expected manner of realisation or settlement of the carrying amount of assets and liabilities, using tax rates enacted, or substantively enacted, by the end of the reporting period. Deferred tax assets are recognised only to the extent that it is probable that future taxable profits will be available against which the asset can be utilised. Deferred tax assets are reviewed at each reporting date and reduced to the extent that it is no longer probable that the related tax benefit will be realised.

Current tax assets and current tax liabilities are offset when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle the asset and the liability on a net basis. Deferred tax assets and deferred tax liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities; and the deferred tax assets and the deferred tax liabilities relate to income taxes levied by the same taxation authority.

2.14 Leases

Company has adopted Ind AS 116 “Leases” Starting April 01, 2019, with initial date of application being April 01, 2019.

Accounting policy upto March 31, 2019:

The Company determines whether an arrangement contains a lease by assessing whether the fulfillment of a transaction is dependent on the use of a specific asset and whether the transaction conveys the right to use that asset to the Company in return for payment. Where this occurs, the arrangement is deemed to include a lease and is accounted for either as finance or operating lease. Leases are classified as finance leases where the terms of the lease transfers substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases. Rentals payable under operating leases are charged to the statement of profit and loss on a straight line basis over the term of the relevant lease unless another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

Accounting policy w.e.f. April 01, 2019

The Company applied Ind AS 16 using the modified retrospective approach with a date of initial application of 1 January 2019 and accordingly the comparative figures have not been restated. Moreover, there was no impact of initial application on the balance of retained earnings as of April 01, 2019. As a result, the Company has changed its accounting policy for lease contracts as detailed below.

The Company as a lessee

At inception of a contract the Company assess whether a contract is, or contain a lease. A contract is, or contains, a lease if contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

The Company recognises a right of use asset and a lease liability at the lease commencement date. The right of use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any lease incentives received.

The right of use asset is subsequently depreciated using the straight-line method from the commencement date to the earlier of the end of the useful life of the right of use asset or the end of the lease term. The estimated useful lives of right of use assets are determined on the same basis as those of property, plant and equipment.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or if that rate cannot be readily determined, the Company's incremental borrowing rate. Generally, the Company uses its incremental borrowing rate as the discount rate. The lease liability is measured at amortised cost using the effective interest method.

The Company as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. To classify each lease, the Group makes an overall assessment of whether the lease transfers substantially all of the risks and rewards incidental to ownership of the underlying asset. If this is the case, then the lease is a finance lease; if not, then it is an operating lease. As part of this assessment, the Group considers certain indicators such as whether the lease is for the major part of the economic life of the asset.

2.15 Non-current assets held for sale and discontinued operations

Non-current assets and disposal groups classified as held for sale are measured at the lower of their carrying value and fair value less costs to sell. Assets and disposal groups are classified as held for sale if their carrying value will be recovered through a sale transaction rather than through continuing use. Non-current assets or disposal groups comprising of assets and liabilities are classified as 'held for sale' when all the following criteria are met: (i) decision has been made to sell, (ii) the assets are available for immediate sale in its present condition, (iii) the assets are being actively marketed and (iv) sale has been agreed or is expected to be concluded within 12 months of the Balance Sheet date.

2.16 Borrowing costs

Borrowing costs consist of interest and other costs that the Company incurred in connection with the borrowing of funds. Borrowing costs that are directly attributable to the acquisition and/or construction of a qualifying asset, till the time such qualifying asset becomes ready for its intended use, are capitalized. A qualifying asset is one that necessarily takes a substantial period to get ready for its intended use.

All other borrowing costs are charged to the Statement of Profit and Loss on an accrual basis as per the effective interest rate method.

2.17 Expenditure

Expenses are accounted on accrual basis except coupon redemption scheme expenses which are recorded on actual payment basis.

The plan provides for a lump-sum payment to vested employees at retirement, death while in employment or on termination of employment of an amount equivalent to 26 days salary payable for each completed year of service. Vesting occurs upon completion of five years of service. The Company has taken a gratuity plan from Life Insurance Corporation (LIC) and annual contributions are made to this plan. The Company accounts for the liability for gratuity benefits payable in the future based on an actuarial valuation.

The defined benefit plans expose the Company to a number of actuarial risks as below:

(a) Interest risk: A decrease in the bond interest rate will increase the plan liability.

(b) Salary risk: The present value of the defined benefit plan liability is calculated by reference to the future salaries of plan participants. As such, an increase in the salary of the plan participants will increase the plan's liability.

We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Report on Other Legal and Regulatory Requirements

(a) The respective Managements of the Company and its subsidiaries which are companies incorporated in India, whose financial statements have been audited under the Act, have represented to us that, to the best of their knowledge and belief, no funds (which are material either individually or in the aggregate) have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by the Company or any of such subsidiary to or in any other persons or entities, including foreign entities ("Intermediaries"), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever ("Ultimate Beneficiaries") by or on behalf of the Company or any of such subsidiary or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.

(b) The respective Managements of the Company and its subsidiaries which are companies incorporated in India, whose financial statements have been audited under the Act, have represented to us that, to the best of their knowledge and belief, no funds (which are material either individually or in the aggregate) have been received by the Company or any of such subsidiary from any persons or entities, including foreign entities ("Funding Parties"), with the understanding, whether recorded in writing or otherwise, that the Company or any of such subsidiary shall directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever ("Ultimate Beneficiaries") by or on behalf of the Funding Parties or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.

(c) Based on the audit procedures performed that have been considered reasonable and appropriate in the circumstances, nothing has come to our notice that has caused us to believe that the representations under sub-clause (i) and (ii) of Rule 11(e) contain any material mis-statement.

v) The final dividend paid by the Company during the current year in respect of the same declared for the previous year is in accordance with section 123 of the Companies Act 2013 to the extent it applies to payment of dividend. As stated in note 45 to the financial statements, the Board of Directors of the Company have proposed final dividend for the current year which is subject to the approval of the members at the ensuing Annual General Meeting. The dividend declared is in accordance with section 123 of the Act to the extent it applies to declaration of dividend.

vi) Based on our examination which included test checks, except for the instances mentioned below, the Company has used accounting softwares for maintaining its books of account, which have a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the respective software:

(i) In case of both holding and subsidiary company incorporated in India, the feature of recorded audit trail (edit log) was not enabled at the database level to log any direct data changes for the accounting software used for maintaining the books of account relating to payroll, consolidation process and certain noneditable fields/tables of the accounting software used for maintaining general ledger.

Further, for the periods where audit trail (edit log) facility was enabled and operated throughout the year for the respective accounting software, we did not come across any instance of the audit trail feature being tampered with.

(vii) With respect to the matter to be included in the Auditors' Report under Section 197(16) of the Act:

In our opinion and according to the information and explanations given to us, the remuneration paid by the company and its subsidiaries to its directors during the current year is in accordance with the provisions of Section 197 of the Act. The remuneration paid to any director is not in excess of the limit laid down under Section 197 of the Act. The Ministry of Corporate Affairs has not prescribed other details under Section 197(16) which are required to be commented upon by us.
