**UPON hearing the counsel the Court made the following
O R D E R**

1. In a similar matter, being SLP (C) No. 26029 of 2026, we have already permitted the petitioner to withdraw the Special Leave Petition to approach the High Court in view of the decision of this Court in *Universal Sompo General Insurance Co. Ltd. vs. Suresh Chand Jain*; 2023 INSC 649: 2023 SCC Online SC 877.

2. The present Special Leave Petitions stand on the same footing and are also permitted to be withdrawn in order to avail the remedy of approaching the High Court. Accordingly, the present Special Leave Petitions are dismissed as withdrawn.

3. Mr Amol B. Karande, learned counsel has fairly brought to our notice that there are many more Special Leave Petitions filed against the decision of National Commission. These matters are SLP (C) Diary Nos. 37204, 37210, 37354, 37482, 37511, 37557, 37578, 37583, 37612, 37613, 37615, 37621, 37626, 37663, 37664, 37667, 37669, 37670, 37673, 37753, 37759, 37777 of 2026. These matters are taken on board with consent. By following the mandate laid down in the *Universal Sampo (supra)*, all these matters are also permitted to be withdrawn for availing the remedy of approaching the High Court. Ordered accordingly.
