PROCEEDINGS OF THE 1ST EXTRA-ORDINARY GENERAL MEETING OF THE FINANCIAL YEAR 2026-27 OF THE EMROCK CORPORATION LIMITED HELD ON SATURDAY, 27TH JUNE, 2026 THROUGH VIDEO CONFERENCING/ OTHER AUDIO-VISUAL MEANS

The 1st Extra-Ordinary General Meeting of the financial Year 2026-27 (“**EGM**”) of the Members of **EMROCK CORPORATION LIMITED** (the ‘**Company**’) was held today i.e. Saturday , 27th JUNE, 2026 at 02:30 PM IST through video conference and other audio-visual means (“**VC/OAVM**”), in compliance with General Circular Nos. 14/2020 dated April 08, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023, latest Circular no. 09/2024 dated September 19, 2024 issued by the Ministry of Corporate Affairs (“**MCA**”) and circulars issued by Securities and Exchange Board of India (SEBI) from time to time (hereinafter collectively referred to as “Relevant Circulars”) and the provisions of the Companies Act, 2013 (“the **Act**”).

Mr. Parth Patel, chaired the meeting.

Mr. Parth Patel, Whole Time Director & CFO of the Company welcomed all the members present in the meeting and introduced all the other Directors, KMPs and other invitees who were present in the EGM. He further informed the Members that the meeting was held through video conference facility provided by NSDL. Since EGM is being held through VC, the facility for appointment of proxies by the members was not applicable and hence no proxy register for inspection was available.

The Chairman then proceeded with the meeting. The Chairman informed the members that the Notice of the Extraordinary General Meeting and the corrigendum to notice of EGM had been sent through electronic mode to those members whose e-mail addresses had been registered with the Company or Depositories. Accordingly, the notice of the EGM was taken as read.

The following items of business, as per the Notice of EGM were read out during the meeting and members who have not voted earlier have been provided with the facility to cast their votes through e-voting facility provided during the EGM at NSDL platform.
