1. Pursuant to the General Circular nos. 14/2020 dated 08th April, 2020; 17/2020 dated 13th April, 2020; 20/2020 dated 05th May, 2020; 02/2021 dated 13th January, 2021; 19/2021 dated 8th December, 2021; 21/2021 dated 14th December, 2021, 02/2022 & 03/2022 dated 5th May, 2022; 10/2022 & 11/2022 dated 28th December, 2022 ; 09/2023 dated 25th September, 2023 & 09/2024 dated 19.09.2024 & General Circular No. 03/2025 Dated: 22.09.2025 issued by the Ministry of Corporate Affairs ("MCA Circular"), Circular no. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated October 06, 2023 ('SEBI circular') SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated October 03, 2024 issued by SEBI (MCA Circular and SEBI Circular collectively referred to as 'Circulars'), companies are allowed to hold AGM through VC, without the physical presence of members at a common venue. Hence, in compliance with the Circulars, the AGM of the Company is being held through VC. The registered office of the Company shall be deemed to be the venue for the AGM.
2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India ("ICSI") and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 read with MCA Circulars, the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.
3. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1,000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.
4. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
5. Pursuant to the provisions of the Companies Act, 2013 ("Act") a Member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his / her behalf and the proxy need not be a Member of the Company. Since this AGM is being held pursuant to the MCA Circulars and SEBI Circulars through VC / OAVM, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence the Proxy Form, Attendance Slip and route map of the AGM are not annexed to this Notice.
6. In case of joint holders, the Member whose name appears as the first holder in the order of names as per the Register of Members of the Company will be entitled to vote at the AGM.
7. In compliance with the aforesaid MCA Circulars and SEBI Circular, Notice of the AGM along with the Annual Report for the financial year 2025-26 is being sent only through electronic mode to those Members whose email addresses are registered with the Company/ Depositories. The Notice calling the AGM has been uploaded on the website of the Company at www.cilsecurities.com. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited at www.bseindia.com. The AGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM) i.e. www.evotingindia.com.
8. Members are requested to note that the dividend remaining unclaimed for a continuous period of seven years from the date of transfer to the Company's Unpaid Dividend Account shall be transferred to the Investor Education and Protection Fund (IEPF). In addition, all equity shares in respect of which dividend has not been claimed for seven consecutive years or more shall be transferred by the Company to demat account

of the IEPF authority within a period of thirty days of such equity shares/dividend becoming due to be transferred to the IEPF. Accordingly, the Company would be transferring the Equity Shares and Final Dividend for the year ended 31st March, 2019. In the event of transfer of equity shares and the unclaimed dividends to IEPF, Members are entitled to claim the same from IEPF authority by submitting an online application in the prescribed Form IEPF-5 available on the website www.iepf.gov.in and sending a physical copy of the same duly signed to the Company along with the requisite documents enumerated in Form IEPF-5. Members can file only one consolidated claim in a financial year as per the IEPF rules.

9. The Company has transferred the unpaid or unclaimed dividends declared up to financial years 2017-18 to the Investor Education and Protection Fund ("IEPF") established by the Central Government. Details of dividends so far transferred to the IEPF Authority are available on the website of IEPF Authority and the same can be accessed through the link: www.iepf.gov.in.
10. The Securities and Exchange Board of India ("SEBI"), vide its Circular No. HO/38/13/11(2)2026-MIRSDPoD/1/3750/2026 dated 30th January 2026 (the "SEBI Circular"), has, inter alia, provided a special window for transfer and dematerialisation of physical equity shares, pursuant to which shareholders are hereby informed that such window shall remain open from 05th February 2026 to 04th February 2027 for transfer and dematerialisation of physical equity shares which were sold or purchased prior to 01st April 2019, including cases where transfer requests were earlier rejected, and that such transfers shall be effected only in dematerialised form and shall be subject to a lock-in period of one year from the date of dematerialisation; accordingly, eligible shareholders holding physical share certificates are advised to contact the Company or its Registrar and Transfer Agent for detailed procedures and documentation required for availing the aforesaid facility.
11. As per Regulation 40 of SEBI (LODR) Regulations, 2015, as amended, securities of listed companies can be transferred only in dematerialized form with effect from 1st April 2019, except in the case of request received for transmission or transposition of securities. In view of this and to eliminate all risks associated with the physical shares and for ease of portfolio management, members holding shares in physical form are

requested to consider converting their holdings in dematerialized form.

12. The Securities and Exchange Board of India ("SEBI") vide its circular dated November 03, 2021; December 14, 2021; March 16, 2023; May 17, 2023 and November 17, 2023 has made it mandatory for the shareholders holding securities in physical form to furnish PAN, KYC and Nomination details to the Registrar and Transfer Agent ('RTA') of the Company.

In view of the above, shareholders of the Company holding securities in physical form are requested to provide the following documents/details to RTA:

- PAN;
- Nomination in Form No.SH-13 or submit declaration to 'Opt-out' in Form ISR-3;
- Contact details including Postal address with PIN code, Mobile Number, E-mail address;
- Bank Account details including Bank name and branch, Bank account number, IFSC number;
- Specimen signature.

Any cancellation or change in nomination shall be provided in Form No.SH-14. All of above required documents/details shall be provided to Company at rta@cilsecurities.com and send the documents at the address of registered office of the company.

The shareholders can download the forms mentioned in SEBI circular from the website of the Company at www.cilsecurities.com.

13. To support the "Green initiative", members who have not yet registered their email addresses are requested to register the same with their DP's in case the shares are held by them in electronic form and with the Company/ RTA if the share are held by them in physical form. A letter containing a web link for accessing the Notice and Annual Report for the financial year 2025-26 will be sent to those shareholders who have not registered their email address with the Company/ Depositories/RTA.
14. Members are requested to intimate changes, if any, pertaining to their Name, Postal Address, E-mail address, telephone/mobile numbers, PAN, Mandates, Nominations, POA, Bank Details such as name of the bank, branch details, bank account number, MICR Code, IFSC Code etc. to their DP's in case the shares are held by them in electronic form and to the company if the shares are held in physical form.

15. The Register of Directors and Key Managerial Personnel and their shareholding maintained under Section 170 of the Act, the Register of Contracts or Arrangements in which the directors are interested, maintained under Section 189 of the Act, and the relevant documents referred to in the Notice will be available electronically for inspection by the members during the AGM. All documents referred to in the Notice will also be available electronically for inspection without any fee by the members from the date of circulation of this Notice up to the date of AGM. Members seeking to inspect such documents can send an email to secretary@cilsecurities.com.

16. The Board of Directors has appointed Mr. Thomas Joseph Lloyd, Practicing Advocate as the scrutinizer to scrutinize the voting during the Remote E-voting and venue voting in a fair and transparent manner.

The Scrutinizer shall after the conclusion of e-voting at the AGM, will first count the votes casted through e-voting at the meeting and thereafter unblock the votes casted through remote e-voting and shall make, not later than two (2) working days of the conclusion of the AGM, a consolidated Scrutinizer's Report of the total votes casted in favor or against, if any, to the Chairman of the meeting or a person authorized by him in writing, who shall countersign the same and declare the result of the voting forthwith.

17. SEBI vide Circular Nos. SEBI/HO/OIAE/OIAE_IAD-1/P/CIR/2023/131 dated July 31, 2023, and SEBI/HO/OIAE/OIAE_IAD-1/P/CIR/2023/135 dated August 4, 2023, read with Master Circular No. SEBI/HO/OIAE/OIAE_IAD-1/P/CIR/2023/145 dated July 31, 2023 (updated as on August 11, 2023), has established a common Online Dispute Resolution Portal ("ODR Portal") for resolution of disputes arising in the Indian Securities Market. Pursuant to above-mentioned circulars, post exhausting the option to resolve their grievances with the RTA/ Company directly and through existing SCORES platform, the investors can initiate dispute resolution through the ODR Portal (<https://smartodr.in/login>) and the same can also be accessed through the Company's website www.cilsecurities.com.

INSTRUCTIONS FOR SHAREHOLDERS FOR REMOTE E-VOTING ARE AS UNDER:

- (i) The voting period begins on 27th September, 2026

at 10.00 A.M.(IST) and ends on 29th September at 5.00 P.M. (IST). During this period Shareholders of the company holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) i.e. 23rd September, 2026 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.

- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India ("ICSI") and Regulation 44 of Listing Regulations read with MCA Circulars, as amended, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/ retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

- (iv) In terms of SEBI circular no. SEBI/HO/CFD/CMD/ CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

Pursuant to above said SEBI Circular, Login method for e-Voting and joining virtual meetings for **Individual shareholders holding securities in Demat mode** is given below:

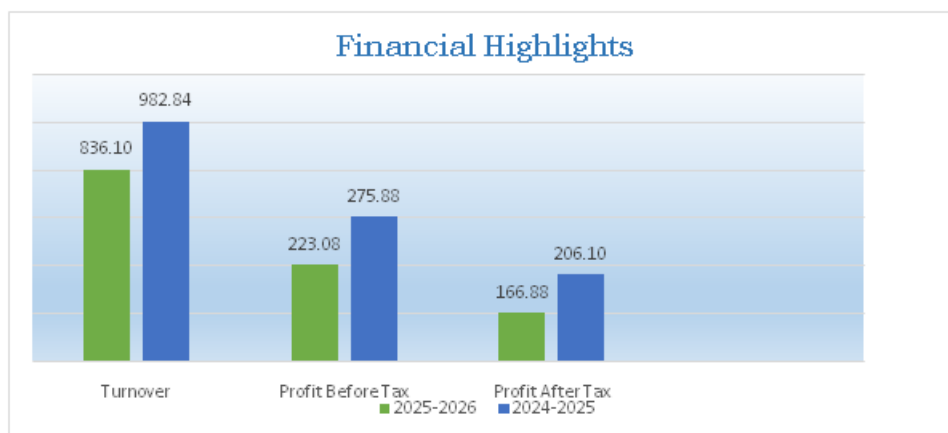

The Company's Profit after Tax for the year is Rs. 166.88 Lakhs as compared to Rs. 206.10 Lakhs in the previous year. The decline in performance is mainly due to volatile market conditions during F.Y. 2025–26. The year was marked by global economic uncertainty, foreign fund outflow, persistent FII selling, rising global inflation and interest rates and geopolitical tensions, particularly in the Middle East, which led to fluctuations in crude oil prices and impacted investor sentiment, reduced trading volumes, and less participation from retail investors.

Despite these market challenges, the Company's disciplined approach to cost management and operational efficiency allowed us to maintain an EBIT margin of 27.06% and a Net Profit Margin of 19.96%, demonstrating resilience in a difficult market environment. We remain committed to optimizing our operations, retaining clients, and strengthening our business to overcome such challenges and build a foundation for future growth.

CHANGE IN THE NATURE OF BUSINESS

There has been no change in the nature of the business of the Company during the Financial Year under review.

HIGHLIGHTS OF PERFORMANCE OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURE COMPANIES AND THEIR CONTRIBUTION TO THE OVERALL PERFORMANCE OF THE COMPANY DURING THE PERIOD UNDER REPORT

The Company does not have any Subsidiaries, Associates and Joint Venture Companies and hence disclosure under this clause is not applicable to the Company for the Financial Year under review.

on 31st March, 2026. An amount of Rs. 150.19 Lakhs is retained in the retained earnings.

MATERIAL CHANGES AND COMMITMENTS

No material changes and commitments, affecting the financial position of the Company have occurred between the end of the financial year of the Company and the date of this report.

MARKETS PERSPECTIVE

F.Y. 2025–26 witnessed a mixed market environment. During the first three quarters, Indian equity markets remained resilient, supported by strong corporate earnings, healthy economic growth, and sustained domestic investor participation. This momentum propelled the Nifty 50 Index to a record high of 26,373 in January 2026, while India's GDP growth strengthened to 7.7%.

Market sentiment weakened in the final quarter due to escalating geopolitical tensions, global trade uncertainties, and disruptions to key shipping routes in West Asia. These factors drove crude oil prices higher, increased market volatility, and triggered significant foreign institutional selling. Consequently, the Nifty 50 corrected and closed the year at 22,820, while the Indian Rupee came under depreciation pressure against the US Dollar.

Despite foreign portfolio outflows, domestic investors continued to support the markets. Strong participation by Domestic Institutional Investors (DIIs), record SIP inflows, and growing mutual fund investments helped absorb selling pressure and provided stability to the capital markets.

BUSINESS OUTLOOK FOR THE YEAR 2026-27.

Global markets are expected to remain influenced by geopolitical developments, trade policies, energy prices, and monetary policy decisions across major economies, resulting in periods of volatility.

However, India is expected to remain among the fastest-growing major economies, supported by strong domestic consumption, continued infrastructure spending, expanding manufacturing capabilities, and ongoing structural reforms.

Corporate earnings are likely to be the key driver of market performance, with investors focusing on companies that demonstrate strong profitability, sound balance sheets, efficient capital allocation, and sustainable competitive advantages. Continued

domestic institutional and retail participation, supported by steady SIP inflows and increasing financial awareness, is expected to provide stability to the markets.

While short-term volatility may persist, India's long-term growth prospects remain favourable, creating opportunities for businesses capable of delivering sustainable earnings growth and long-term value.

CONCLUDING REMARKS

Despite global uncertainties, India's economic fundamentals remain strong and its capital markets continue to demonstrate resilience. Growing domestic investor participation has strengthened market stability and reduced dependence on foreign capital flows.

As F.Y. 2026–27 unfolds, disciplined capital allocation, sound governance, and a focus on fundamentally strong businesses will remain critical for long-term value creation. Supported by favourable demographics, ongoing reforms, infrastructure development, and rising domestic consumption, India remains well-positioned for sustained economic growth and wealth creation. We remain optimistic about India's long-term prospects and committed to pursuing growth opportunities while maintaining a prudent and disciplined approach to value creation.

STATE OF THE COMPANY'S AFFAIRS

During the financial year 2025-26, the Company reported revenue from operations of Rs. 836.10 lakhs, a decline of 14.93% from Rs. 982.84 lakhs in FY 2024-25. EBIT stood at Rs. 226.23 lakhs (PY: Rs.290.85 lakhs), and EBT was Rs 223.08 lakhs (PY: Rs.275.88 lakhs). Net Profit declined by 19.03% to Rs. 166.88 lakhs in FY 2025-26 as compared to Rs. 206.10 lakhs in FY 2024-25.

Financial Year 2025-26 has been a challenging year for the company, despite the challenges, we are committed in strengthening our business to overcome such challenges and build a foundation for future growth.

3. Mr. Krishna Kumar Maheshwari ceased to be the Chief Financial Officer of the Company with effect from 26th, July 2025.

4. Mr. Vinod Kumar Sabavath was appointed as the Chief Financial Officer of the Company with effect from 27th, July 2025.

NOMINATION, REMUNERATION AND EVALUATION POLICY

The Nomination, Remuneration and Evaluation Policy of the Company, adopted by the Board in accordance with the provisions of Section 178(3) of the Act based on the recommendations made by the Nomination and Remuneration Committee, lays down criteria for:

- i. Determining qualifications, positive attributes required for appointment of Directors, Key Managerial Personnel and Senior Management and also the criteria for determining the independence of a Director;
- ii. Appointment, tenure, removal/ retirement of Directors, Key Managerial Personnel and Senior Management;
- iii. Determining remuneration (fixed and performance linked) payable to the Directors, Key Managerial Personnel and Senior Management; and
- iv. Evaluation of the performance of the Board and its constituents.

The Company has uploaded the Nomination, Remuneration and Evaluation Policy on its website on www.cilsecurities.com.

CRITERIA FOR MAKING PAYMENT TO THE DIRECTORS

i. SITTING FEES

Non-Executive Directors (NED) may receive remuneration by way of fee for attending meetings of the Board of Directors of the Company ("Board") or any committees thereof ("Committee(s)") or any other meeting as required by the Companies Act, 2013, as amended ("the Act"), the Listing Regulations or other applicable laws or for any other purpose whatsoever as may be decided by the Board. Provided that the amount of such fees shall not exceed Rupees one lakh per meeting of the Board or Committee or such amount as may be prescribed by the Central Government from time to time.

ii. REMUNERATION

Section 197 of the Act allows a Company to pay remuneration to its directors on the Board of the Company ("Director") either by way of a monthly payment or at a specified percentage of the net profits of the Company or partly by one way and partly by the other. Further, the Section 197 also states that where the Company has a managing or whole-time Director or manager, then a maximum of 1% of its net profits can be paid as remuneration to its NEDs. In any other case, then a maximum of 3% of net profit can be paid. Thus, the basis of payment to the NEDs is the net profit of the Company. As per regulation 17 of Listing Regulations, the approval of shareholders by special resolution shall be obtained every year, in which the annual remuneration payable to a single NED exceeds fifty per cent of the total annual remuneration payable to all NED, giving details of the remuneration thereto.

iii. PROFESSIONAL FEES

Section 197 of the Act allows a Company to pay remuneration to its NEDs for services rendered by any such Director if:

- a. The services rendered are of professional nature;
- b. In the opinion of Nomination and Remuneration Committee the Director possesses the requisite qualification for the practice of the profession.

iv. REIMBURSEMENT OF ACTUAL EXPENSES INCURRED

NEDs may also be paid/reimbursed such sums either as fixed allowance and /or actual as fair compensation for travel, boarding and lodging and incidental and /or actual out of pocket expenses incurred by such NED for attending the Board/Committee meetings or for the Company's work. The Nomination and Remuneration Committee is entrusted with the role of reviewing the compensation of NEDs.

v. PAYMENT TO INDEPENDENT DIRECTORS

An Independent Director shall not be entitled to any stock option and may receive remuneration only by way of fees and reimbursement of expenses for participation in meetings of the Board or any Committee thereof and profit related commission up to a certain percentage

of net profits in such proportion, as may be permissible under the applicable law.

PERFORMANCE EVALUATION OF BOARD, COMMITTEES AND DIRECTORS

The Annual performance evaluation of the Independent Directors, Non-Independent Directors, Chairman and the Board as a whole (including its Committees) was carried out in the manner given below:

- i. Performance evaluation of the Independent Directors was done by the entire Board (excluding the Director being evaluated);
- ii. Independent Directors, in their separate meeting held on 14th March, 2026, reviewed the performance of the Non-Independent Directors and the Board as a whole (including its Committees); and
- iii. Independent Directors, in their separate meeting, also reviewed the performance of the Chairman after taking into account the views of all the Directors.

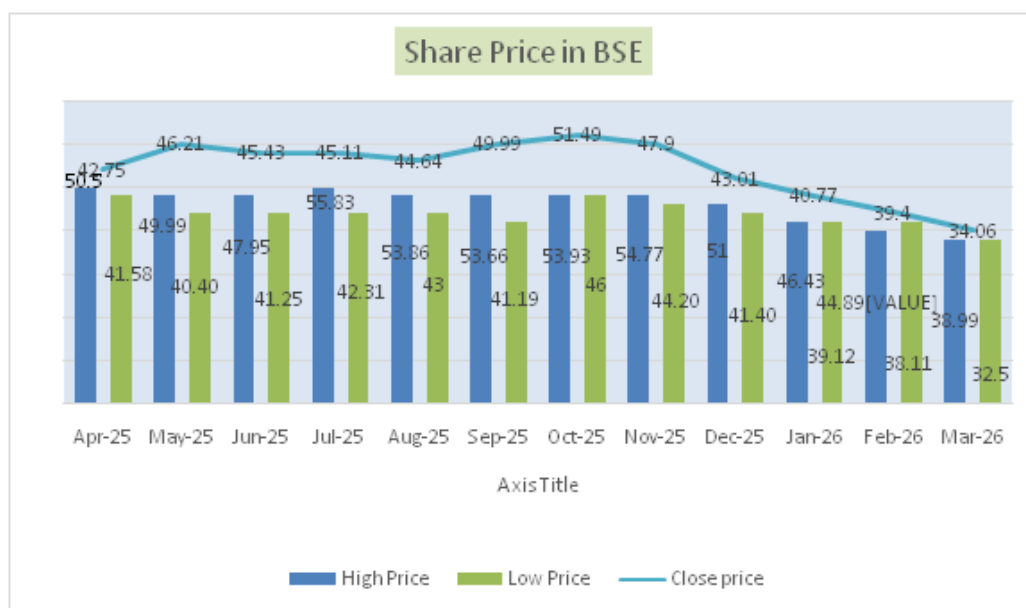

EBIT stood at Rs. 226.23 lakhs (PY: Rs.290.85 lakhs), and EBT was Rs 223.08 lakhs (PY: Rs. 275.88 lakhs). Net Profit declined by 19.02%, from Rs.206.10 lakhs to Rs.166.88 lakhs.

During the financial year 2025-26, the Company reported a decline of 19.02% in net profit compared to the previous year, primarily due to industry-wide factors affecting the stock broking sector. The period witnessed moderation in trading volumes, particularly in the derivatives segment, coupled with reduced retail investor participation driven by market volatility and cautious sentiment. Additionally, regulatory tightening, including stricter margin requirements and reduced leverage, impacted trading activity and revenue generation. The industry also continued to face intense competition from discount brokers, leading to pressure on brokerage yields. Further, increased compliance and technology-related costs contributed to higher operational expenses. Despite these challenges, the Company maintained stable operations and continued to focus on strengthening its systems, compliance framework, and client base, positioning itself for sustainable long-term growth.

Outlook

The outlook for the stock broking industry remains cautiously optimistic, supported by strong domestic economic fundamentals, increasing financialization of savings, and continued growth in retail investor participation over the long term. However, near-term challenges such as regulatory tightening, evolving margin norms, and intermittent market volatility may continue to impact trading volumes and brokerage revenues. Additionally, ongoing geopolitical tensions in the Middle East have contributed to global market uncertainty, volatility in crude oil prices, and cautious investor sentiment, which may indirectly affect capital market activity. Notwithstanding these factors, structural drivers including rising demat account penetration, digital adoption, and expansion of capital markets are expected to provide growth opportunities. The Company remains focused on leveraging technology, enhancing client engagement, diversifying revenue streams, and maintaining robust risk and compliance frameworks to navigate these challenges and position itself for sustainable growth in the coming years.

Challenges, Risk, Concern

The Company faces normal business challenges of market competition in its business and needs to continuously

seek attractive growth opportunities. The Company adopts suitable business strategies to counter these challenges.

As a part of the overall risk management strategy, the Company consistently insures its assets and generally follows a conservative financial profile by following prudent business practices.

Internal Control System and their adequacy

The Company has a proper and adequate internal control system commensurate with its size and nature of business to meet the following objectives:

- Providing assurance regarding the effectiveness and efficiency of operations;
- Efficient use and safeguarding of resources;
- Compliance with policies, procedures and applicable laws and regulations;
- The systems are IT enabled which facilitate effective checks and tight monitoring of all parameters and control on continuous basis.

The Audit Committee actively reviews the adequacy and effectiveness of internal control systems and suggests improvements for strengthening measures from time to time.

Risk assessment reports received from various departments are reviewed periodically and steps are initiated for elimination whenever needed.

Human Resource Development

The Company has a group of able and experienced employees. The Company believes that the quality of its employees is the key to its success in the long run. The Company continues to have cordial relations with its employees and provides personal development opportunities for all round exposure to them. As on 31st March, 2026, Company had 38 employees.

24. Corporate Information

CIL Securities Limited was incorporated on June 29, 1989. The Company is a member of National Stock Exchange of India Limited (NSE), Bombay Stock Exchange Limited (BSE), Multi Commodity Exchange of India Limited (MCX), and a Category-I Merchant Bankers, Category-I Registrar & Share Transfer Agents and Depository Participant with Central Depository Services (India) Limited (CDSL).

The Company is engaged in the business of stocks, currency and commodity broking, providing margin trading facility, depository services, RTA Services, Equity Valuation and distributor of mutual funds. Its Registered Office is situated at Hyderabad, India. The registered office address of the Company is 214, Raghva

Ratna Towers, Chirag Ali Lane, Abids, Hyderabad-500001.

Significant Accounting Policies

24.1 Basis of Preparation of Financial Statement

- i) **Statement of Compliance :** The Financial Statements comply in all material aspects with Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 (the "Act") [Companies (Indian Accounting Standards) Rules, 2015] and other relevant provisions of the Act.
- ii) **Basis of Preparation**
1. **Compliance with IND AS**

The Financial Statements comprising of Balance Sheet, Statement of Profit and Loss including

other comprehensive income, Statement of Changes in Equity and Statement of Cash Flows as at March 31, 2026 have been prepared in accordance with Ind AS as prescribed under Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and companies (Indian Accounting Standards) Amendment Rules, 2016.

These Financial Statements have been approved for issue by the Board of Directors at their meeting held on 9th May 2026. These Financial Statements are presented in Indian Rupees (INR), and **all values are rounded to the nearest lakhs**, which is also the functional and presentation currency.

2. Historical Cost Convention

The Company follows the mercantile system of accounting and recognizes income and expenditure on an accrual basis. The Financial Statements are prepared under the historical cost convention, except in case of significant uncertainties and except for the following:

- Certain Financial Assets and Liabilities that are measured at fair value;
- Defined benefit plans where plan assets are measured at fair value;
- Investments are measured at fair value.

3. Preparation of Financial Statements

The Company is covered in the Division II as defined in Companies (Indian Accounting Standards) (Amendment) Rules, 2016. As per the format prescribed under Division II of Schedule III to the Companies Act, 2013, the Company presents the Balance Sheet, the Statement of Profit and Loss and the Statement of Changes in Equity.

24.2 Use of estimates

The preparation of the financial statements are in conformity with Ind AS which requires the Management to make estimates and assumptions that affect the reported amounts of assets, liabilities and disclosure of Contingent Assets and liabilities as of the date of financial statement and the income and expenses for the reporting period. The Company makes certain judgments and estimates for valuation and

impairment of financial instruments, useful life of property, plant and equipment, deferred tax assets, provision and contingencies. Management believes that the estimates used in the preparation of the financial statements are prudent and reasonable.

24.3 Revenue Recognition

The Company recognizes revenue from contracts with customers based on a five step model as set out in Ind AS 115, Revenue from Contracts with Customers, to determine when to recognize revenue and at what amount. Revenue is measured based on the consideration specified in the contract with a customer. Revenue from contracts with customers is recognized when services are provided and it is highly probable that a significant reversal of revenue is not expected to occur.

Revenue is measured at fair value of the consideration received or receivable. Revenue is recognized when (or as) the Company satisfies a performance obligation by transferring a promised service (i.e. an asset) to a customer. An asset is transferred when (or as) the customer obtains control of that asset. When (or as) a performance obligation is satisfied, the Company recognizes as revenue the amount of the transaction price (excluding estimates of variable consideration) that is allocated to that performance obligation.

- (i) Revenue from contract with customer is recognized point in time when performance obligation is satisfied. ***Income from broking activities is accounted for on the trade date of transactions.***
- (ii) ***Income from sales of Shares and Securities*** are recognized on the date of the relevant transactions.
- (iii) ***Depository services income*** are accounted as follows: Revenue from depository services on account of annual maintenance charges have been accounted for over the period of the performance obligation. Revenue from depository services on account of transaction charges is recognized point in time when the performance obligation is satisfied.
- (iv) ***Income from Merchant Banking Income*** is accounted on accrual basis.

- (v) **Equity Index / Stock Futures / Currency Futures:** Equity Index / Stock Futures/ Currency Futures are marked to market on a daily basis.

Debit or Credit balance disclosed under Loans and Advances or Financial Liabilities, respectively, in the Mark to Market Margin Equity Index / Stock Futures/Currency Account, represents the net amount payable or receivable on the basis of movement in the process of Index / Stock futures /Currency Futures on the Balance Sheet date.

- (vi) **Option Contracts:**At the time of final settlement Premium paid/ received is recognized as an expense/ income on exercise of Option .Further, difference between the final settlement price as on the exercise/ expiry date and the strike price is recognized as Income/ Loss.

At the time of squaring off difference between the premium paid and received on squared off transaction is treated as Profit or Loss

- (vii) **Interest income** is accounted on accrual basis and the same is treated as Business Income.
- (viii) Dividend income is recognized when the right to receive the dividend is established, it is probable that the economic benefits associated with the dividend will flow to the entity and the amount of the dividend can be measured reliably.
- (ix) Delayed payment charges (Interest on late payments) are accounted at a point in time of default.
- (x) In respect of other heads of Income it is accounted to the extent it is probable that the economic benefits will flow and the revenue can be reliably measured, regardless of when the payment is being made.

24.4 Property, Plant and Equipment

(i) Recognition and Measurement

Property, plant and equipment are stated in the balance sheet at their carrying value being the cost of acquisition less accumulated depreciation. The cost comprises purchase price, borrowing cost if capitalization criteria are met and directly attributable cost of bringing the asset to its working condition for the intended use. Any trade discount and rebates are deducted in arriving at the purchase price. Subsequent costs are included in the asset's carrying amount or

recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with these will flow with the company. All other repair and maintenance costs are recognized in statement of profit or loss as incurred.

(ii) Depreciation, Estimated Useful Lives and Residual Value

Depreciation on property, plant and equipment is provided on written down value method, computed on the basis of useful lives as estimated by management which coincides with rates prescribed in Schedule II to the Companies Act, 2013.

- (iii) **De-recognition:** An item of property, plant and equipment and any significant part initially recognized is de-recognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on de-recognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the income statement when the asset is de-recognized.

24.5 Intangible Assets:

Intangible assets (software) are stated in the balance sheet at their carrying value being the cost of acquisition less accumulated depreciation. The cost comprises purchase price, borrowing cost if capitalization criteria are met and directly attributable cost of bringing the asset to its working condition for the intended use. Any trade discount and rebates are deducted in arriving at the purchase price.

Amortization of intangible assets is provided on Written down value method computed on the basis of useful life estimated at 5 years with zero residual value. Any expenses on such software for support and maintenance payable annually are charged to the statement of profit and loss.

24.6 Financial Instruments

(i) Date of Recognition

Financial assets and financial liabilities are recognized in the company's balance sheet when the company became a party to the contractual provisions of the instrument.

(ii) Initial Measurement

Financial assets and liabilities, with the exception of loans, debt securities, deposits and borrowings are initially recognized on the trade date, i.e. the date that the Company becomes a party to the contractual provisions of the instrument. Recognized financial instruments are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss Account.

24.7 Classification and Subsequent Measurement**A). Financial Assets**

- **Debt Instruments at Amortized Cost** : – A 'debt instrument' is measured at the amortized cost if both the following conditions are met:

- The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and
- Contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

- **Equity Instruments**

All equity investments in scope of Ind-AS 109 are measured at fair value. Equity instruments which are held for trading are classified as at fair value through profit and loss (FVTPL). For all other equity instruments, the Company decides to classify the same either as at fair value through other comprehensive income (FVOCI) or fair value through profit and loss (FVTPL). The Company makes such election on an instrument-by-instrument basis. The classification is made on initial recognition and is irrevocable.

- **Mutual funds**

All mutual funds in scope of Ind-AS 109 are measured at fair value through profit and loss (FVTPL).

(B) Financial Liability

Financial liabilities are measured at amortized cost. The carrying amounts are initially recognised at fair value and subsequently determined based on the EIR method. Interest expense is recognised in profit or loss. Any gain or loss on de-recognition of financial liabilities is also recognised in profit or loss. The Company does not have any financial liability which is measured at FVTPL.

24.8 Reclassification

Financial assets are not reclassified subsequent to their initial recognition, apart from the exceptional circumstances in which the Company acquires, disposes of, or terminates a business line or in the period the Company changes its business model for managing financial assets. Financial liabilities are not reclassified.

24.9 De Recognition**A) Financial Assets****A financial asset is de-recognized when:**

- The contractual rights to receive cash flows from the financial asset have expired, or
- The Company has transferred its rights to receive cash flows from the asset and the Company has transferred substantially all the risks and rewards of the asset, or the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

On De- recognition of a financial asset, the difference between the carrying amount of the asset and the sum of (i) the consideration received (including any new asset obtained less any new liability assumed) and (ii) any cumulative gain or loss that had been recognised in OCI is recognised in profit or loss.

(B) Financial Liabilities

A financial liability is derecognized when the obligation under the liability is discharged, cancelled or expires. Where an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is

treated as a de-recognition of the original liability and the recognition of a new liability. In this case, a new financial liability based on the modified terms is recognized at fair value. The difference between the carrying value of the original financial liability and the new financial liability with modified terms is recognised in profit or loss.

24.10 Impairment of Non-Financial Assets

The carrying values of assets / cash generating units at each Balance Sheet date are reviewed for impairment. If any indication of impairment exists, the recoverable amount of such assets is estimated and impairment is recognized, if the carrying amount of these assets exceeds their recoverable amount. The recoverable amount is the greater of the net selling price and their value in use. Value in use is arrived at by discounting the future cash flows to their present value based on an appropriate discount factor. When there is indication that an impairment loss recognized for an asset in earlier accounting periods no longer exists or may have decreased, such reversal of impairment loss is recognised in the Statement of Profit and Loss, except in case of revalued assets.

24.11 Retirement and Other Employee Benefits

(i) Provident Fund

Retirement benefit in the form of provident fund is a defined contribution scheme. The Company has no obligation, other than the contribution payable to the provident fund. The Company recognizes contribution payable to the provident fund scheme as an expense, when an employee renders the related service.

(ii) Gratuity

Every employee is entitled to a benefit equivalent to 15 days salary last drawn for each completed year of service in line with The Payment of Gratuity Act, 1972. The same is payable at the time of separation from the Company or retirement, whichever is earlier. The benefit vest after five years of continuous service

The Company's gratuity scheme is a defined benefit plan. The Company's net obligation in respect of the gratuity benefit scheme is calculated by estimating the amount of future

benefit that the employees have earned in return for their service in the current and prior period. Such benefit is discounted to determine its present value, and the fair value of any plan assets, if any, is deducted.

The present value of the obligation under such benefit plan is determined based on actuarial valuation.

(iii) Compensated Absences

Compensated absences benefits are expected to be paid in exchange for the services rendered by the employees during the year. These benefits are expected to occur within twelve months after the end of the period in which the employee renders the related service.

The cost of such compensated absences is accounted as under:

- (a) In case of accumulated compensated absences, when employees render the services that increase their entitlement of future compensated absences; and
- (b) In case of non-accumulating compensated absences, when the absences occur.

24.12 Cash and Cash Equivalents

Cash and cash equivalents includes cash at banks and on hand, demand deposits with banks, other short-term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents cash and short-term deposits are considered integral part of the Company's cash management.

24.13 Provisions, Contingent Liabilities and Contingent Assets

A provision is recognized when the Company has a present obligation as a result of a past event and it is probable that an outflow of resources will be required to settle the obligation and there is a reliable estimate of the amount of the obligation. Provisions are measured at the best estimate of the expenditure required to settle the present obligation at the Balance sheet date.

Contingent liabilities are not recognized but are disclosed in the notes. Contingent assets are

neither recognized nor disclosed in the financial statements. Provisions are reviewed at each balance sheet date and adjusted to effect current management estimates. Contingent liabilities are recognized when there is possible obligation arising from past events.

24.14 Income Tax

Income tax expense comprises current and deferred tax. It is recognized in statement of profit and loss except to the extent that it relates to items recognized directly in equity or in OCI.

(i) Current Tax

Current tax is measured at the amount expected to be paid in respect of taxable income for the year in accordance with the Income Tax Act, 1961.

(ii) Deferred Tax

Deferred tax is provided using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements.

Deferred tax assets arising mainly on account of carry forward losses.

Deferred tax assets on account of other temporary differences are recognized only to the extent that there is reasonable certainty that sufficient future taxable income will be available against which such deferred tax assets can be realized.

Deferred tax assets and liabilities are measured using tax rates and tax laws that have been enacted or substantively enacted at the Balance Sheet date. Changes in deferred tax assets / liabilities on account of changes in enacted tax rates are given effect to in the statement of profit and loss in the period of the change. The carrying amount of deferred tax assets are reviewed at each Balance Sheet date.

Deferred tax assets and deferred tax liabilities are off set when there is a legally enforceable right to set-off assets against liabilities representing current tax and where the deferred tax assets and deferred tax liabilities relate to taxes on income levied by the same governing taxation laws.

(iii) Minimum Alternate Tax (MAT)

During the Financial Year, Company has opted for New Scheme u/s 115BAA and accordingly MAT is not applicable from F.Y 2022-23 and onwards.

24.15 Earning Per Share (Basic and Diluted)

Basic earnings per share is computed by dividing the profit / (loss) after tax (including the post-tax effect of extraordinary items, if any) by the weighted average number of equity shares outstanding during the year. Diluted earnings per share is computed by dividing the profit / (loss) after tax (including the post-tax effect of extraordinary items, if any) as adjusted for dividend, interest and other charges to expense or income relating to the dilutive potential equity shares, by the weighted average number of equity shares considered for deriving basic earnings per share and the weighted average number of equity shares which could have been issued on the conversion of all dilutive potential equity shares.

Potential equity shares are deemed to be dilutive only if their conversion to equity shares would decrease the net profit per share from continuing ordinary operations. Potential dilutive equity shares are deemed to be converted as at the beginning of the period, unless they have been issued at a later date. The dilutive potential equity shares are adjusted for the proceeds receivable had the shares been actually issued at fair value (i.e. average market value of the outstanding shares). Dilutive potential equity shares are determined independently for each period presented. The number of equity shares and potentially dilutive equity shares are adjusted for share splits / reverse share splits and bonus shares, as appropriate.

24.16 Borrowing Costs

General and specific borrowing costs that are directly attributable to the acquisition of a qualifying asset are capitalized during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying asset are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Other borrowing costs are expensed in the period in which they are incurred.

24.17 Goods and Services Tax paid on Acquisition of Assets or on incurring Expenses

Expenses and assets are recognized net of GST paid except when the tax incurred on a purchase of assets or services is not recoverable/eligible for ITC from the Tax authority, in which case the tax paid is recognized as part of the cost of acquisition of the asset or as part of the expenses item as applicable.

24.18 Segment Reporting

The Company identifies primary segments based on the dominant source, nature of risks and returns and the internal organization and management structure. The operating segments are the segments for which separate financial information is available and for which operating profit/loss amounts are evaluated regularly by the executive Management as defined in Ind AS

108 in deciding how to allocate resources and in assessing performance.

The accounting policies adopted for segment reporting are in line with the accounting policies of the Company. Segment revenue, segment expenses, segment assets and segment liabilities have been identified to segments on the basis of their relationship to the operating activities of the segment.

Revenue, expenses, assets and liabilities which relate to the Company as a whole and are not allocable to segments on reasonable basis have been included under "unallocated revenue / expenses / assets / liabilities".

24.19 Foreign Currency

Transactions in foreign currencies are recorded at the rate of exchange prevailing on the date of the transaction. Exchange differences arising on Settlement of revenue transactions are recognized in the statement of profit and loss.
