**ORDER**  
**(Hybrid Mode)**

**IA/848(AHM)2026**

1. This Application has been filed by the Resolution Professional under Section 12(2) of the Insolvency and Bankruptcy Code, 2016 read with Regulation 40 of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 seeking extension of the Corporate Insolvency Resolution Process period by 90 days from 02.06.2026 to 31.08.2026, with the following prayers:
  - a. *To extend the period of CIRP of Corporate Debtor for 90 days commencing from 02.06.2026 to 31.08.2026*
  - b. *Issue such other necessary orders as this Hon'ble Court may deem fit.*
2. The Corporate Debtor was admitted into Corporate Insolvency Resolution Process vide order dated 03.12.2025 passed in CP (IB) No. 377(AHM) of 2025. The initial period of 180 days has expired on 01.06.2026.

3. It is submitted that Form-G was issued on 31.01.2026 and was re-issued on 03.03.2026 pursuant to the decision of the Committee of Creditors. Expressions of Interest were received from prospective resolution applicants. The resolution process is under progress and additional time is required for completion of the Corporate Insolvency Resolution Process.
4. The Committee of Creditors, in its 6th meeting held on 19.05.2026, approved extension of the Corporate Insolvency Resolution Process period and authorised the Resolution Professional to file the present Application.
5. Having considered the Application, documents placed on record and the resolution passed by the Committee of Creditors, this Adjudicating Authority is satisfied that sufficient cause exists for extension of the Corporate Insolvency Resolution Process period.
6. The period of Corporate Insolvency Resolution Process in respect of Blu-Smart Fleet Private Limited is extended by 90 days from 02.06.2026 till 31.08.2026.
7. The Resolution Professional shall complete the Corporate Insolvency Resolution Process within the extended period in accordance with the provisions of the Insolvency and Bankruptcy Code, 2016 and the Regulations framed thereunder.
8. Accordingly, **I.A. No. 848 of 2026** stands allowed and disposed of.
