Godrej Properties wins auction for residential land parcel in Greater Noida

(GPL), (BSE scrip id: GODREJPROP), one of India's leading real estate developers, today announced that it has won the bid for a 23.2 acres (93,905 sq. mtr.) residential land parcel in DMIC integrated township, Greater Noida, through an e-auction conducted by DMIC Integrated Industrial Township Greater Noida Limited.
