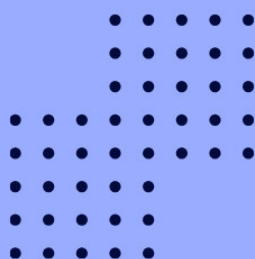

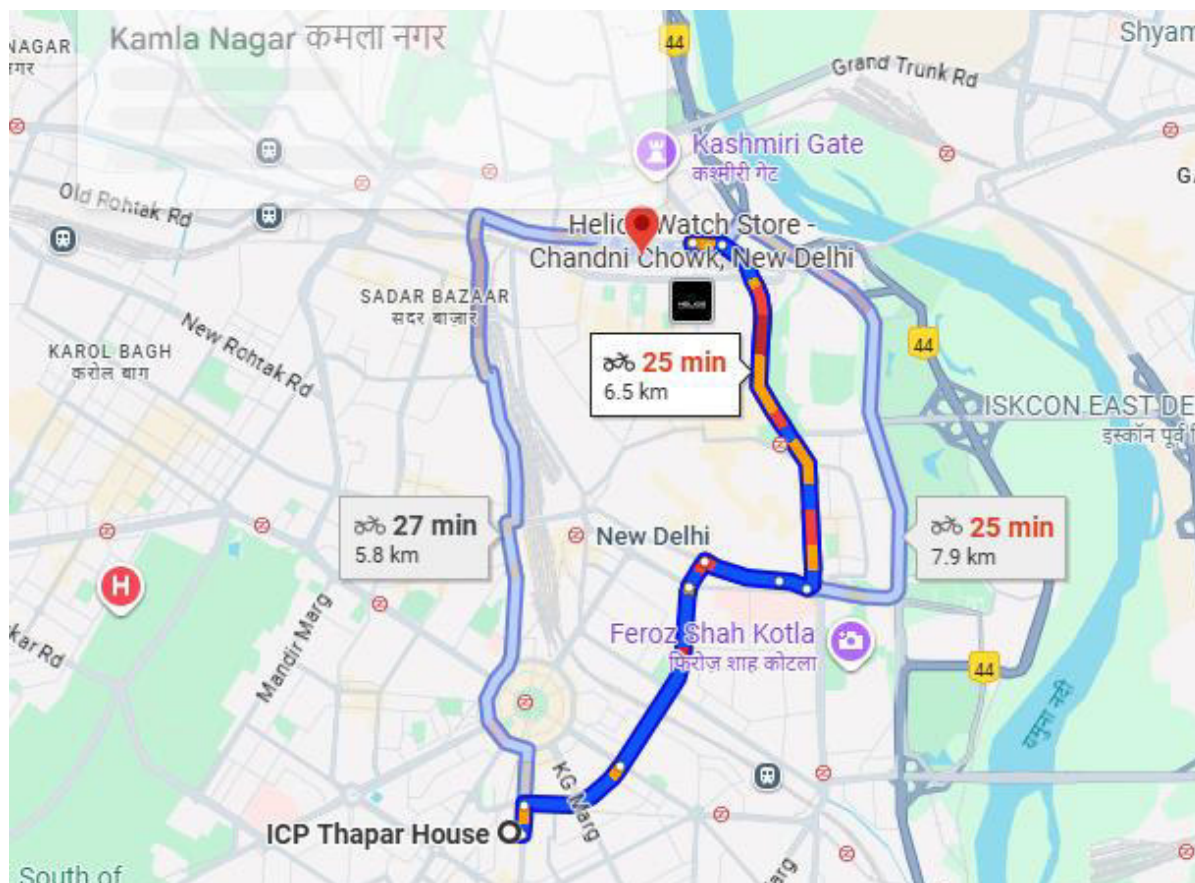

MANAGEMENT DISCUSSION & ANALYSIS REPORT

“A year of turnaround — translating operational discipline and prudent stewardship into a return to profitability.”

◇ Industry Structure and Developments

The Non-Banking Financial Company (NBFC) sector remains a vital pillar of India's financial ecosystem, extending credit and services to segments that traditional banking channels often leave underserved. Financial Year 2025-26 saw the sector navigate a gradual recovery, persistent inflationary pressures, and interest-rate volatility. Continued regulatory support from the Reserve Bank of India, alongside a sustained emphasis on liquidity management, helped reinforce the sector's overall resilience.

India's GDP growth eased to 6.5 per cent in FY 2024-25, following three consecutive years of robust expansion averaging 8.8 per cent. The moderation was largely a function of softer urban consumption amid elevated inflation and interest rates, subdued momentum in fixed investment, and a slower start to government spending on account of the national and state elections held during the year.

The underlying strength of India's economy and the soundness of its financial system provided a solid platform from which the Company operated through FY 2025-26. While the Reserve Bank of India has projected some moderation in growth for FY 2026-27 amid global geopolitical and monsoon-related uncertainties, the overall outlook for the financial sector remains constructive.

◇ Opportunities and Threats

The Company's financial performance this year marks a decisive turnaround. Having recorded a net loss of ₹3,37,965 in FY 2024-25, the Company closed FY 2025-26 with a net profit of ₹21,38,907 — its first profitable year following a period of sustained consolidation.

This is more than an improved number on a balance sheet — it is confirmation that the Company's turnaround strategy has taken hold. With a clear, forward-looking vision and firm confidence in the strength of its foundation, the Company has converted the lessons of past challenges into concrete results, setting the stage for sustainable growth, operational excellence, and long-term value creation.

◇ Business Overview

The Company is driven by a singular vision: a more financially inclusive India. Its continued focus on niche and underbanked segments extends access to formal finance while enabling genuine economic empowerment for the communities it serves. Anchored by a well-defined market strategy, rigorous regulatory compliance, and performance-driven goals, the Company continues to widen its footprint across the financial sector — delivering solutions that are as inclusive in reach as they are effective in impact.

◇ Outlook

The NBFC sector stands at the threshold of continued transformation, shaped by advancing technology, evolving regulatory reforms, and ongoing consolidation. Having returned to profitability, the Company enters FY 2026-27 with renewed confidence, prioritising stronger underwriting standards, deeper digital integration, and more robust recovery mechanisms. The year ahead will see the Company build on this momentum, growing its loan book cautiously, sharpening asset quality, and working purposefully to sustain and deepen profitability.

◇ Financial Performance

The Company reported a net profit of ₹21,38,907 for FY 2025-26, as against a net loss of ₹3,37,965 recorded in the previous financial year — a turnaround underpinned by three reinforcing factors:

- A substantial increase in total income, from ₹14,41,371 in FY 2024-25 to ₹39,88,200 in FY 2025-26.

- Improved cost discipline, with total expenses declining from ₹17,79,103 to ₹14,53,155 over the same period.
- Stronger asset quality and more effective recovery mechanisms, supporting sustained operational efficiency.

The Company also maintained a cautious and selective approach to disbursements, with a deliberate tilt toward lower-risk segments. The scale of this turnaround is a clear marker of the Company's strategic shift toward sustainable growth and prudent financial stewardship, and management remains focused on consolidating this profitability in the years ahead.

◇ Economic Overview

India's economy demonstrated notable resilience through FY 2025-26, underpinned by steady GDP growth, strengthening consumption, and sustained government investment in infrastructure. Inflationary pressures, though present, were managed effectively, aided by a balanced monetary policy stance from the RBI. The financial services sector, in turn, benefited from improved liquidity conditions and rising credit penetration — particularly across underbanked and semi-urban regions, where the Company's own strategic focus is concentrated.

◇ Risks and Concerns

The Company's risk landscape is shaped by several interconnected factors, each actively monitored and managed:

- Credit risk — arising from the possibility of borrower default.
- Liquidity risk — stemming from potential mismatches in asset-liability tenures or constrained access to funding during periods of market stress.
- Interest rate risk — volatility that can compress net interest margins and elevate borrowing costs.
- Regulatory risk — an evolving compliance landscape under RBI and other regulatory bodies, where tightening norms or revised provisioning requirements could influence profitability and capital adequacy.

◇ Internal Control Systems and Their Adequacy

Robust internal controls are the backbone of trust in any NBFC — safeguarding the accuracy of financial reporting, ensuring regulatory compliance, and underpinning operational effectiveness. These systems are the Company's first line of defence against credit defaults, operational lapses, financial misstatements, and non-compliance.

The Company has instituted a comprehensive internal control framework designed to protect its assets, uphold prudent lending discipline, and support sound, timely decision-making — while embedding transparency, accountability, and rigorous risk management into everyday operations.

◇ Human Capital

People remain the Company's most valuable asset. In an NBFC, human capital is the engine behind growth, compliance, and customer-centric service — the skills, experience, and commitment of the workforce directly shape the Company's ability to manage financial risk, meet regulatory expectations, drive operational efficiency, and innovate in lending and financial services.

◇ Disclosures

Transparency is central to the Company's relationship with its stakeholders. Operating under the regulatory purview of the Reserve Bank of India, the Company is committed to providing accurate, timely, and comprehensive disclosure of its financial position, operational performance, risk management practices, and governance framework.

All material developments — including changes in accounting policy, related-party transactions, governance structures, or significant business risks — are communicated openly and responsibly through periodic reports, investor updates, regulatory filings, and public disclosures.

Notes to standalone financial statements for the year ended 31 March 2026:

About the Company:

Nikki Global (CIN No L65999DL1986PLC024493) registered under ROC Delhi incorporated on 13/06/1986. Nikki Global Finance Limited is a comprehensive credit institution that provides a wide range of diversified debt products. Nikki global was incorporated as a high standard credit institution that helps in leveraging the experience of comprehensive practices and local economic development to meet and greet the ever-increasing credit requirements of Indian corporates and individuals. The company is registered under section 45-IA of RBI Act,1934, which is not having CoR classified as NBFC-ICC).

Basis of preparation:

The financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as prescribed in the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time and notified under section 133 of the Companies Act, 2013 (the Act) along with other relevant provisions of the Act, the updated Master Direction – Non-Banking Financial Company – Systemically Important Non Deposit taking Company and Deposit taking Company (Reserve Bank) Directions, 2016 (‘the NBFC Master Directions’), notification for Implementation of Indian Accounting Standards issued by RBI vide circular RBI/2019-20/170 DOR(NBFC).CC.PD.No.109/22.10.106/2019-20 dated 13 March 2020 (‘RBI notification for Implementation of Ind AS’) and other applicable RBI circulars/notifications. The Company uses accrual basis of accounting in preparation of financial statements except in case of significant uncertainties. The standalone financial statements are presented in Indian Rupee (INR), which is also the functional currency of the Company. The standalone financial statements have been prepared on a historical cost basis, except for certain financial instruments that are measured at fair value. The financial statements are prepared on a going concern basis as the Management is satisfied that the Company shall be able to continue its business for the foreseeable future and no material uncertainty exists that may cast significant doubt on the going concern assumption. In making this assessment, the Management has considered a wide range of information relating to

present and future conditions, including future projections of profitability, cash flows and capital resources.

Presentation of financial statements:

The Company presents its Balance Sheet in the order of liquidity. The Company prepares and presents its Balance Sheet, the Statement of Profit and Loss and the Statement of Changes in Equity in the format prescribed by Division III of Schedule III to the Act. The Statement of Cash Flows has been prepared and presented as per the requirements of Ind AS 7 'Statement of Cash Flows'. The Company generally reports financial assets and financial liabilities on a gross basis in the Balance Sheet. They are offset and reported net only where it has legally enforceable right to offset the recognized amounts and the Company intends to either settle on a net basis or to realize the asset and settle the liability simultaneously as permitted by Ind AS. Similarly, the Company offsets incomes and expenses and reports the same on a net basis where the netting off reflects the substance of the transaction or other events as permitted by Ind AS.

Summary of significant accounting policies:

This note provides a list of the significant accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated.

i) Revenue from Operations:

The Company recognizes revenue from contracts with customers (other than financial assets to which Ind AS 109 'Financial instruments' is applicable) based on a comprehensive assessment model as set out in Ind AS 115 'Revenue from contracts with customers'. The Company identifies contract(s) with a customer and its performance obligations under the contract, determines the transaction price and its allocation to the performance obligations in the contract and recognizes revenue only on satisfactory completion of performance obligations. Revenue is recognized at transaction price is net of variable consideration on account of various discounts and schemes offered by the Company as part of the contract. Revenue in case of non-cash consideration is recognized at fair value.

Dividend income on equity shares is recognized when the Company's right to receive the payment is established, which is generally when shareholders approve the dividend.

Income on non-performing assets is recognized in accordance with the provisions of Prudential Norms for Income Recognition prescribed by the Reserve Bank of India and is accounted for in the year of realization.

.

ii) Current versus non-current classification:

The company presents assets and liabilities in the balance sheet based on current/ non-current classification. An asset is treated as current when it satisfies any of the following criteria:

- Expected to be realized or intended to be sold or consumed within normal operating cycle.
- Held primarily for the purpose of trading.
- Expected to be realized within twelve months after the reporting date, or
- Cash or cash equivalent unless restricted from being exchanged or used to settle liability for at least twelve months after the reporting date. A liability is treated as current when it satisfies any of the following criteria:
 - Expected to be settled in the company's normal operating cycle;
 - Held primarily for the purpose of trading;
 - Due to be settled within twelve months after the reporting date; or
 - The Company does not have an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.
- Terms of a liability that could, at the option of the counterparty, result in its settlement by the issue of equity instruments does not affect its classification. Current liabilities include the current portion of non-current financial liabilities. All other liabilities are classified as non-current.

The Company has ascertained its operating cycle as twelve months for the purpose of current and non-current classification of assets and liabilities.

iii) Use of Estimates and management judgements:

The preparation of financial statements in conformity with Indian Accounting Standards (Ind AS) requires management of the company to make judgements, estimates and assumptions that affect the reported amount of revenues, expenses, assets, liabilities and related disclosures concerning the items involved as well as contingent assets and liabilities at the balance sheet date. The estimates and management's judgements are based on previous experience and other factors considered reasonable and prudent in the circumstances. Actual results may differ from these estimates.

iv) Property, Plant & Equipment & Capital work in Progress:

Recognition and measurement Property, plant and equipment are tangible items that are held for use in the production or supply for goods and services, rental to others or for administrative purposes and are expected to be used for more than one period. The cost of an item of property, plant and equipment is being recognized as an asset if and only if it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The PPE has been stated at cost less accumulated depreciation.

Intangible assets are recognized when it is probable that the future benefits that are attributable to the assets will flow to the Company and the cost of the assets can be measured reliably. Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less accumulated amortization and accumulated impairment losses, if any.

Depreciation has been provided on WDV Basis Method.

v) Inventories:

The inventories of shares & securities have been valued at lower of cost price or market value as at 31st March, 2026.

vi) Revenue recognition:

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured.

Interest –

Income Interest income from a financial asset is recognized when it is probable that the economic benefit will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Dividend Income –

Dividend income is recognized when the Company's right to receive the dividend is established, it is probable that the economic benefits associated with the dividend will flow to the entity and the amount of the dividend can be measured reliably i.e. in case of interim dividend, on the date of declaration by the Board of Directors; whereas in case of final dividend, on the date of approval by the shareholders.

vii) Expenses: All expenses are accounted for on accrual basis.

viii) Financial Instruments:

Financial Asset Classification The company classifies financial assets as subsequently measured at amortized cost, fair value through other comprehensive income or fair value through profit or loss on the basis of its business model for managing the financial assets and contractual cash flow characteristics of the financial asset.

Initial Recognition and Measurement:

All financial assets are recognized initially at fair value, in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset. The financial assets include equity and debt securities, trade and other receivables, loans and advances, cash and bank balances and derivative financial instruments.

Equity Investments:

All the investments have been valued at deemed cost. (Note No. 5 to the financial statements)

Loans:

Loans have been carried at amortized cost. (Note No. 4 to the financial statements).

ix) Financial liabilities:

Classification Debt and equity instruments issued by the company are classified as either financial liabilities or as equity in accordance with the substance of the contractual agreements and the definitions of financial liability and equity instrument.

Initial recognition and measurement:

The company recognizes financial liability when it becomes a party to the contractual provision of the instrument. All financial liabilities are recognized initially at fair value, for financial liability not subsequently measured at FVTPL, at transaction costs that are directly attributable to the issue of financial liability.

Loans:

Other loans classified under financial liability have been carried at amortized cost. (Note no. 13 to the financial statements).

x) Others:

- a. Loans and advances are stated net of provisions for non-performing advances. Balances of various parties are subject to confirmations.

- b. The company has not entered into any lease agreement, therefore, provisions of Indian Accounting Standard-116 on 'Leases' are not applicable.
- c. To the extent information available, there were no outstanding dues towards small scale or ancillary undertaking as on 31.03.2026.
- d. During the year under consideration no borrowing cost has capitalized by the company in accordance with the Indian Accounting Standard 23. 'Borrowing Costs' issued by the Institute of Chartered Accountants of India.
- e. The advance received or given is without any stipulation of board of directors regarding them in nature and period for which they are given or received.

xi) Taxes:

Provision for tax on income for the year (i.e. Current tax) is made after considering the various Deductions/relieves admissible under the Income Tax Act 1961 as per the normal provisions of the act. Deferred tax assets are recognized as per the conservative approach. Keeping in view the current year losses of the company, net deferred tax liabilities have not been recognized in accordance with Indian Accounting Standard IND AS-12- "Accounting for taxes on income" issued by the Institute of Chartered Accountants of India".

xii) Provisions:

Provisions are recognized when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. The expense relating to a provision is presented in the statement of profit or loss net of any reimbursement. Provisions are not recognized for future operating losses If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

Contingent liabilities are possible obligations that arise from past events and whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events not wholly

within the control of the Company. Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. As mentioned in the notes to account no. 38, the management has stated an amount of Rs. 42.11 lakhs as contingent liability.

Contingent asset is not recognized but disclosed, when possible, asset that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the entity. Provisions, contingent liabilities and contingent assets are reviewed at each balance sheet date.

xiii) Cash flows:

are stated using the indirect method, whereby profit/loss before tax is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and items of incomes and expenses associated with investing or financing flows. The cash flows from operating, investing and financing activities of the Company are segregated.
