Two weeks' time, as last opportunity, is granted to respondent Nos.1, 2, 19 to 21, 27, 30 to 32 & 35 (Caveators) to file counter affidavit. If counter affidavit is filed as above, let the same be taken on record, else further opportunity to file counter affidavit would stand declined, as caveats were filed in April/May, 2026.

Service was complete on respondent No.6 on 06.06.2026, but none has entered appearance.

Two weeks' time, as last opportunity, is granted to respondent Nos.7, 10 & 18 to file counter affidavit. If counter affidavit is filed as above, let the same be taken on record, else further opportunity to file counter affidavit would stand declined, as service was complete in June 2026.
