Sub.: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 –Regarding Imagicaa’s Water Park at Khopoli

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that the Company is in receipt of communication from the Irrigation Department, Government of Maharashtra, directing the company to refrain from utilizing water from the dams, highlighting low water levels in the dams in surrounding region, considering the prevailing El Nino effect.

Considering the same, the management shall be temporarily closing the operation of **Imagicaa Water Park** located at 30/31, Sangdewadi, Khopoli - Pali Road, Taluka Khalapur, District Raigad – 410 203, Maharashtra w.e.f June 19, 2026 until the water situation improves.

The Company will closely track the developments and would update on the resumption of operations of said Water Park at Khopoli.

The detailed disclosure, as required under the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 updated on January 30, 2026, is enclosed as Annexure A to this letter.
