ORDER

The present Company Application has been filed by the Applicant-**Loveleen Dhaliwal Singla**, who is the Petitioner in CP No.16/Chd/Chd/2025 for seeking suspension and removal of Respondents No.2 and 3 from the Directors.

2. We have heard, Ld. Counsel, Mr. Aalok Jagga appearing for the Applicant. He has drawn our attention to our order dated 07.07.2026,

whereby direction was given to R2 and R3 to provide the list of the machineries and their location.

3. It is also observed therein that in case, they fail to furnish the list of such machineries within a week, then this Tribunal shall consider for their removal from management of the company.

After considering the submissions made by the Ld. Counsel Mr. Aalok Jagga, we deem it appropriate to issue notice of this Company Application to the Respondents.

Ld. Counsel, Mr. Ashutosh Hasija appears for the Respondent No.2 and Ld. Counsel, Mr. Sushant Kareer appears for the Respondent No.3 and accept the notice. Therefore, the requirement of serving the notice with respect to Respondents No.2 and 3 is dispensed with. Reply be filed within a week with a copy in advance to the counsel opposite.

As regards to the remaining Respondents, the Applicant shall collect the notice from the Registry and send the same by speed post as well as by e-mail, if available, to the Respondent attaching therewith copy of the application and the entire paper book and the copy of this order as well. The applicant shall file affidavit of service supported by postal receipt, tracking report and copy of e-mail within one week. Reply be filed within one week with a copy in advance to the counsel opposite.

3. Since, the main CP is already listed on 30.07.2026, list this Application also on the very same date i.e. **30.07.2026**.
