The instant writ petition has been preferred by

the petitioner for the following reliefs:

a. For Quashing the entire results/verification process/schedule started on 08.06.2026 and wrong answer key or answer published(twice) by the respondent pursuant to the advertisement dated 02.06.2025 (Annexure-1) in respect to Jharkhand Trained Madhyamik Acharya Combined Competitive Examination (JTMACCE-2025) conducted by the Respondent-Jharkhand Staff Selection Commission (herein after referred as JSSC) and declaring the entire result process null and void as the same has been done with major inconsistencies and irregularities by publishing the wrong answer key twice and on that basis respondent concerned published the result and thereafter started the verification process the candidates who have passed the examination on wrong question key or answer published (twice) by the respondent- JSSC in question thereby vitiating the sanctity of the entire examination process.

AND/OR

b. For directing the respondents to re-evaluate the answer sheets accurately, correct the discrepancies regarding the wrong answer and publish a fresh rectified result/merit list.

c. For direction upon the respondents to produce before this Hon'ble Court the entire file and records of the selection process undertaken for result of JTMACCE-2025 which would show the entire selection has been done dehors the terms and conditions as mentioned in the Advertisement dated 02.06.2025 and smacks of malice favoritism and nepotism.

AND/OR

d. For direction upon the respondent state to constitute a high-level Committee by an impartial authority to enquire about the malpractice and irregularities committed during the publishing the result or process pursuant to the advertisement dated 02.06.2025(Annexure-1)

e. For issuance of an appropriate writ(s)/order(s) /direction(s) particularly a writ in the nature of mandamus commanding upon the respondent to immediately and forthwith consider?

2. Learned counsel for the petitioner submits that the instant application may be disposed of by granting liberty to the petitioner to approach the Examination Controller of JSSC (Respondent no. 5), to consider her grievance.

3. Learned counsel for the respondents submits that since no counter affidavit has been filed; accordingly, the petitioner if so chooses she may approach the Examination Controller of JSSC- Respondent no.5.

4. Having regard to the above, the instant writ application stands disposed of by granting liberty to the petitioner to approach the Examination Controller of JSSC-Respondent no. 5 by filing fresh representation within a period of 10 days from today.

Needless to say, if the petitioner approaches the Examination Controller of JSSC-Respondent no. 5, he shall verify the records of the case and consider her representation within a period of 3 weeks from the date of receipt of such representation. It goes without saying that if the claim of the petitioner is found genuine, necessary order be passed.

5. With the aforesaid observations/direction, the instant writ application stands disposed of.
