ORDER:

The petitioner has filed this writ petition alleging that respondent No.2 is not receiving and considering the representation dated 13.07.2026 submitted by it.

2. Heard learned counsel for the petitioner and learned Assistant Government Pleader for Home appearing for the respondents.

3. Learned counsel for the petitioner submits that the petitioner approached respondent No.2 to give representation but it was not

received. Subsequently, the petitioner sent the same through registered post. The petitioner apprehends that necessary police protection/bandobast will not be granted for the vigraha consecration to be held from 20.07.2026 to 14.09.2026 on account of Ashadamas Ekadasi Ustavas and he also relies upon the interim order granted by this Court in favour of the petitioner on earlier occasions i.e., W.P.No.5768 of 2017, W.P.No.36580 of 2024, W.P No.71 of 2025.

4. The learned Assistant Government Pleader for Home, however, seeks time to get instructions in the matter.

5. This Court, however, finds that the petitioner has made a representation to respondent No.2/Station House Officer, Kamareddy Town Police Station, Kamareddy, instead of approaching the Superintendent of Police of the district concerned who is the competent authority to grant permissions in such cases.

6. In view thereof, this Court directs the petitioner to approach the authority concerned and if such a representation is made, the Superintendent of Police concerned shall consider the same

expeditiously and pass appropriate orders and provide police protection/bandobast to the vigraha consecration to be held from 20.07.2026 to 14.09.2026 on account of Ashadamasa Ekadasi Ustavas.

7. The writ petition is, accordingly, disposed of. There shall be no order as to costs.

As a sequel, miscellaneous petitions pending, if any, shall stand closed.
