O R D E R

1. By this application, the applicants, M/s Indian Overseas Bank and Bank of India, seek modification of observations in paragraph 20.8 of our judgment dated 24.02.2026 in Civil Appeal No. 7140 of 2022. The relevant portion of paragraph 20.8 is reproduced as under:-

*“20.8 The properties in question, having been provisionally attached and confirmed by the Adjudicating Authority under the Benami Act, stand vested in the Central Government under Section 27, subject to statutory appeal.
XXX”*

2. The application is allowed, and paragraph 20.8 of our judgment dated 24.2.2026 shall now be substituted as under:-

*“20.8 The properties in question, having been provisionally attached and confirmed by the Adjudicating Authority under the Benami Act, would stand vested in the Central Government upon passing of order under Section 27, subject to statutory appeal.
XXX”*

3. The Judgment and Order dated 24.02.2026 stands modified only to the extent as indicated hereinabove. Rest of the Judgment shall remain unaltered.

4. With these modifications, the misc. application is disposed of.
