1. A member entitled to attend & vote at AGM is entitled to appoint a proxy to attend and vote on his/her behalf at the AGM, and the proxy need not be a member of the Company. Since this AGM is being held pursuant to the Circulars through VC / OAVM, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice. However, Body Corporates are entitled to appoint authorised representatives to attend the AGM through VC/OAVM and participate thereat & cast their votes through e-voting. Since AGM will be held through VC/OAVM, route map is not annexed to this Notice.
2. **The Register of Members & Share Transfer Registers of Company will remain closed from Friday, September 18, 2026, to Thursday, September 24, 2026 (both days inclusive).**
3. (a) Members holding shares in physical form are requested to advise immediately change in their address, if any, quoting their folio number(s) to the Registrar & Share Transfer Agent, M/s. Purva Sharegistry (India) Pvt. Ltd.
(b) Members holding shares in the electronic form are requested to advise immediately change in their address, if any, quoting their Client ID No., to their respective Depository Participants.
4. Members desirous of getting any information in respect of accounts of the Company and proposed resolution, are requested to send their queries in writing to the Company at its registered office at least 7 days before the date of the meeting, so that the required information can be made available at the meeting.
5. The Securities and Exchange Board of India (SEBI) has mandated the submission of Permanent Account Number (PAN) by every participant in securities market. Members holding shares in electronic form are, therefore, requested to submit their PAN to their Depository Participants with whom they are maintaining

their demat accounts. Members holding shares in physical form can submit their PAN to the Company / Registrar M/s. Purva Shareregistry (India) Pvt. Ltd.

6. The Ministry of Corporate Affairs ("Ministry"), Government of India, has taken a "Green Initiative in Corporate Governance" by allowing paperless compliances by companies through electronic mode. As per the Circular No. 17/2011, dated 21.04.2011 and Circular No. 18/2011, dated 29.04.2011 issued by the Ministry of Corporate Affairs, companies can now send various notice/documents (including notice calling Annual General Meeting, Audited Financial Statements, Directors Report, Auditors Report, etc.) to their shareholders through electronic mode, to the registered email address of the shareholders.
7. With a view to using natural resources responsibly, we request shareholders to update their email address with their Depository Participants or RTA (i.e. M/s. Purva Shareregistry (India) Pvt. Ltd.) to send communications electronically.
8. The Company has already joined the Depository System and the ISIN for the equity shares of the Company is **INE690D01014**. Members holding shares in physical mode are requested to convert their holdings into Dematerialized mode.
9. Non-Resident Indian Members are requested to update M/s. Purva Shareregistry (India) Pvt. Ltd. immediately of change in their residential status on return to India for permanent settlement.
10. **Voting through electronic means:**

In compliance with the provisions of Section 108 of the Act read with Rule 20 of Companies (Management and Administration) Amendment Rules, 2015, and Regulation 44 of the SEBI [Listing Obligations and Disclosure Requirements (LODR)] Regulations 2015 including amendments thereof, the Company is pleased to provide its shareholders with the facility of "remote E-Voting" (e-voting from a place other than venue of the AGM), to enable them to cast their votes at the **56th AGM** and the business at the **56th AGM** may be transacted through such voting. The Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating e-voting to enable all its shareholders to cast their vote electronically.

The facility for remote e-voting i.e. electronic voting system is made available. The members attending the meeting, who have not already cast their vote through remote e-voting shall be able to exercise their voting rights during the meeting through online link. The members who have already cast their vote through remote e-voting may attend the meeting but shall not be entitled to cast their vote again during the AGM.

11. Meeting through Video Conferencing:

1. As you are aware, in view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021, Circular No. 20/2021 dated December 8, 2021, Circular No. 21/2021 dated December 14, 2021, Circular No. 2/2022 dated May 5, 2022, Circular No 10/2022 dated December 12, 2022, General Circular No. 09/2023 dated September 25, 2023, General Circular No. 09/2024 dated September 19, 2024 and General Circular No. 03/2025 dated September 22, 2025. The forthcoming AGM will thus be held through video conferencing (VC) or other audio visual means (OAVM). Hence, Members can attend & participate in ensuing AGM through VC/OAVM.
2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020, May 05, 2020, January 13, 2021, December 8, 2021, December 14, 2021, May 5, 2022, December 12, 2022, September 25, 2023, September 19, 2024 and September 22, 2025 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.
3. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to atleast 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.
4. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
5. Pursuant to Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021, Circular No.

20/2021 dated December 8, 2021, Circular No. 21/2021 dated December 14, 2021, Circular No. 2/2022 dated May 5, 2022, Circular No 10/2022 dated December 12, 2022, General Circular No. 09/2023 dated September 25, 2023, General Circular No. 09/2024 dated September 19, 2024 and General Circular No. 03/2025 dated September 22, 2025 the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM through VC/OAVM and cast their votes through e- voting.

6. In line with the Ministry of Corporate Affairs (MCA) Circulars mentioned above, the Notice calling the AGM has been uploaded on the website of the Company at www.subhashsilk Mills.com. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited at www.bseindia.com. The AGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM) i.e. www.evotingindia.com.
7. The AGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021, Circular No. 20/2021 dated December 8, 2021, Circular No. 21/2021 dated December 14, 2021, Circular No. 2/2022 dated May 5, 2022, Circular No 10/2022 dated December 12, 2022, General Circular No. 09/2023 dated September 25, 2023, General Circular No. 09/2024 dated September 19, 2024 and General Circular No. 03/2025 dated September 22, 2025.
8. **THE INTRUCTIONS OF SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGS ARE AS UNDER:**

Step 1 : Access through Depositories CDSL e-Voting system in case of individual shareholders holding shares in demat mode.

Step 2 : Access through CDSL e-Voting system in case of shareholders holding shares in physical mode and non-individual shareholders in demat mode.

- (i) The voting period begins on **Monday, September 21, 2026 at 9:00 a.m. and will end on Wednesday, September 23, 2026 at 5:00 p.m.** During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of **Thursday, September 17, 2026** may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that participation by public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. 3. **PERFORMANCE REVIEW (Amount in Hundreds):**

During FY 2025-26, the Company continued to operate in a challenging business environment, which impacted its financial performance. Despite the difficult market conditions, the Company remained focused on sustaining its operations and strengthening its long-term business prospects.

- **Total Income** stood at **₹1,27,047.29** as against **₹2,44,698.85** in the previous financial year, primarily due to a significant reduction in Other Income.
- **Income from Operations** increased to **₹3,062.24** from **₹2,840.02** in FY 2024-25, reflecting a modest improvement in the Company's core operating activities.
- **Total Expenses** decreased to **₹2,02,204.73** compared to **₹2,47,155.28** in the previous year, indicating the Company's continued focus on cost optimization and operational efficiency.
- As a result, the Company reported a **Loss Before Tax** of **₹75,157.43** during FY 2025-26, as against a **Loss Before Tax** of **₹2,456.42** in FY 2024-25. The higher loss was mainly attributable to the substantial decline in Other Income despite lower operating expenses.
- **Net Loss After Tax** stood at **₹76,571.33** for FY 2025-26 compared to **₹22,055.83** in the previous year. While the financial performance was affected during the year, the management remains committed to improving operational performance, optimizing costs, and pursuing strategic initiatives to enhance business growth and create sustainable long-term value for stakeholders.

4. **DIVIDEND:**

In order to reserve funds for its operational activities, your Directors do not recommend any dividend for the Financial Year ended **March 31, 2026**.

MANAGEMENT DISCUSSION & ANALYSIS REPORT

Indian Economic & Textile Industry overview –

The Indian economy continued to demonstrate resilience during FY 2025-26 despite persistent global uncertainties, supported by steady domestic demand, public infrastructure investment, and improving macroeconomic fundamentals. While global challenges such as geopolitical tensions, inflationary pressures, fluctuating commodity prices, and evolving trade dynamics continued to influence economic activity, India remained one of the fastest-growing major economies.

The Indian textile and apparel industry continues to be one of the country's largest employment-generating sectors and a significant contributor to exports and industrial production. The sector contributes around 2% to India's GDP and approximately 10% of the country's merchandise exports. During the year, the textile industry witnessed mixed trends. While domestic demand remained relatively stable and certain export segments showed signs of improvement, manufacturers continued to face challenges arising from volatile raw material prices, pricing pressures, changing consumer demand, and global economic uncertainty.

The Government's continued policy support through initiatives such as the **Production Linked Incentive (PLI) Scheme, PM MITRA Mega Textile Parks, RoDTEP**, and emphasis on technical textiles, sustainability, and value-added manufacturing is expected to strengthen the long-term growth prospects of the sector. Increasing global preference for sustainable and responsibly sourced textile products also presents opportunities for Indian manufacturers to enhance their competitiveness in international markets.

Opportunities & Threats –

The Indian textile industry offers significant long-term growth opportunities driven by expanding domestic consumption, increasing demand for sustainable and value-added textile products, and diversification of global sourcing destinations. India's integrated textile value chain, abundant raw material availability, skilled workforce, and supportive government initiatives position the industry favourably for future growth. Growing investments in technology, technical textiles, and sustainable manufacturing practices are expected to further strengthen the sector's competitiveness.

However, the industry continues to face several challenges. Volatility in cotton and synthetic fibre prices, fluctuations in energy and logistics costs, global inflationary pressures, and uncertain demand in key export markets may continue to impact profitability. Intense competition from other textile-producing countries, changing trade policies, compliance requirements, foreign exchange fluctuations, and increasing sustainability expectations from global customers remain key risks for the industry.

Financial Performance (Amount in Hundreds) –

During FY 2025-26, the Company reported Total Income of ₹1,27,047.29 as compared to ₹2,44,698.85 in the previous financial year, primarily due to a significant reduction in Other Income. Income from Operations improved marginally to ₹3,062.24 from ₹2,840.02 in FY 2024-25, reflecting continued business

operations despite challenging market conditions. Total Expenses stood at ₹2,02,204.73, compared to ₹2,47,155.28 in the previous year. The Company reported a Loss Before Tax of ₹75,157.43 as against a Loss Before Tax of ₹2,456.42 in the previous year. Consequently, the Net Loss After Tax for FY 2025-26 stood at ₹76,571.33, compared with ₹22,055.83 in FY 2024-25.

The management continues to focus on cost optimisation, operational efficiency, prudent financial management, and exploring business opportunities to strengthen the Company's performance. Your Directors remain confident that these initiatives will contribute positively towards improving the Company's financial performance in the coming years.

Risks & Concerns –

The Company operates in a competitive and evolving business environment and is exposed to various business, operational, and financial risks. Fluctuations in raw material prices, particularly cotton and synthetic fibres, continue to influence production costs and margins. Rising energy, transportation, and labour costs, together with supply chain disruptions and changing regulatory requirements, may also impact operational performance.

The Company also faces competitive pressures from domestic and international textile manufacturers, technological changes, evolving customer preferences, foreign exchange fluctuations, and credit risks arising from delays in customer payments. Management continuously monitors these risks and undertakes appropriate mitigation measures to minimise their impact on business operations.

Internal Control Systems –

The Company has established adequate internal control systems commensurate with the nature, size, and complexity of its business operations. These systems are designed to ensure the orderly and efficient conduct of business, safeguarding of assets, accuracy and reliability of financial reporting, compliance with applicable laws and regulations, and prevention and detection of frauds and errors.

The internal audit function independently evaluates the effectiveness of internal controls and risk management processes and submits its reports to the Audit Committee. Significant observations and recommendations are reviewed by the Audit Committee and appropriate corrective actions are implemented by the management. The Board believes that the Company's internal control systems remain adequate and effective for its business operations.

Background "1"

Subhash Silk Mills Limited is a Public Limited company having CIN: L17106MH1970PLC014868 having its registered office address of its registered Office is G-15, Ground Floor, Premkutir, 177, Marine Drive, Mumbai 400 020 and is engaged in manufacturing of fabrics and warehousing activities.

The financial statements for the year ended March 31, 2026 were approved by the Board of Director and authorized for issue on May 29, 2026.

Significant Accounting Policies "2"**Basis of accounting**

In accordance with the notification issued by the Ministry of Corporate Affairs, the Company has adopted Indian Accounting Standards (referred to as "Ind AS") notified under the Companies (Indian Accounting Standards) Rules, 2015 with effect from April 1, 2017.

These financial statements have been prepared in accordance with Ind AS as notified under the Companies (Indian Accounting Standards) Rule, 2015 read with Section 133 of the Companies Act, 2013.

a. Use of estimates

The presentation of Financial Statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and expenses and disclosure of contingent liabilities. The estimates and assumption used in the accompanying Financial Statements are based upon management's evaluation of the relevant facts and circumstances as of the date of the financial statement. Actual results may differ from the estimates and assumptions used in preparing the accompanying Financial statements.

b. Basis of preparation

These financial statements have been prepared on the historical cost basis, except for certain financial instruments which are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

c. Property, plant & equipment

Property, Plant and Equipment's are stated at cost of acquisition, including any attributable cost for bringing the asset to its working condition for its intended use, less accumulated depreciation and impairment loss except plant & machinery, which have revalued, are stated at revalued figure.

Intangible assets purchased are measured at cost or fair value as of the date of acquisition, as applicable, less accumulated amortization and accumulated impairment, if any.

d. Depreciation

Depreciation is provided on the Straight-Line Method at the manner prescribed under schedule II of the companies Act, 2013.

e. Inventories

Inventories of Fabrics is valued at Lower of cost and market value

f. Investment

i) Non-current investment is carried at fair value through OCI.

ii) Current investment is carried at fair value through OCI.

g. Revenue recognition

i) The revenue is recognized as and when goods are dispatched to the party, in case of sale of services on completion of Job and in case of sale of trading, on raising of invoice and transfer of material to the party.

ii) Other income is recognized on accrual basis.

h. Retirement benefits

PF and other retirement benefits are not applicable to the Company.

Gratuity is accounted for as per Ind AS-19 issued by the Institute of Chartered Accountants of India, on the basis of actuarial valuation.

i. Foreign currency transactions

Foreign currency transactions are recorded at the exchange rates prevailing on the date of transaction. Gains & Losses arising out of subsequent fluctuations are accounted for on actual payment or realization. Current assets & liabilities denominated in foreign currency as at the Balance Sheet date are converted at the exchange rates prevailing on that date. Exchange differences are recognized in the Profit & Loss Account.

j. Taxes on income

Current tax is determined as the amount of tax payable in respect of estimated taxable income for the year. Deferred tax is recognized subject to the consideration of prudence, on timing deference, being the difference between taxable income & accounting income that originate in one period and are capable of reversal in one or more subsequent periods.

k. Financial assets and liabilities

Financial assets and liabilities are recognized when the Company becomes a party to the contractual provisions of the instrument. Financial assets and liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value measured on initial recognition of financial assets or financial liability.

l. Borrowing cost

Borrowing cost incurred in relation to the acquisition, construction of asset is capitalized as the part of the cost of such assets up to the date when such assets are ready for intended use. Other borrowing costs are charged as expenses in the year in which these are incurred.

m. Impairment of assets

Impairment loss is provided to the extent the carrying amounts of assets exceed their recoverable amount. Recoverable amount is the higher of an assets net selling price and its value in use. Value in use is the present value of estimated future cash flows expected to arise from the continuing use of an asset and from its disposal at the end of its useful life. Net selling price is the amount obtainable from the sale of an asset in an arm's length transaction between knowledgeable, willing parties, less the costs of disposal.

n. Provisions & contingent liabilities

The Company creates a provision where there is present obligation as a result of past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. When there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resource is remote, no provision or disclosure is made.

o. Cash and cash equivalents

The Company considers all highly liquid financial instruments, which are readily convertible into know amounts of cash that are subject to an insignificant risk of change in value and having original maturities of three months or less from the date of purchase, to be cash equivalents. Cash and cash equivalents consist of balance with banks which are unrestricted for withdrawal and usage.

p. Financial assets at fair value through other comprehensive income

Financial assets are measured at fair value through other comprehensive income if these financial assets are held within a business whose objective is achieved by both collecting contractual cash flows that give rise on specified dates to solely payments of principal and interest on the principal amount outstanding and by selling financial assets.

The Company has made an irrevocable election to present in other comprehensive income subsequent changes in the fair value of equity investments not held for trading.

q. Financial assets at fair value through profit or loss

Financial assets are measured at fair value through profit or loss unless it is measured at amortized cost or at fair value through other comprehensive income on initial recognition. The transaction costs directly attributable to the acquisition of financial assets and liabilities at fair value through profit or loss are immediately recognized in profit or loss.

r. Financial liabilities

Financial liabilities are measured at amortized cost using the effective interest method.

s. Equity instruments

An equity instrument is a contract that evidences residual interest in the assets of the company after deducting all of its liabilities.

t. Intangible assets

Intangible assets purchased are measured at cost or fair value as of the date of acquisition, as applicable, less accumulated amortization and accumulated impairment, if any.
