This has reference to our earlier announcements dated February 26, 2025 and May 12, 2026, wherein Company has informed about suspension of operations of MIC Insurance Web Aggregator Private Limited (MIC), a wholly-owned subsidiary of the Company, and subsequent surrender of its web aggregator license & closure of business.

In this regard, we would like to inform that the Insurance Regulatory and Development Authority of India (IRDAI) vide letter dated August 05, 2026, approved the voluntary surrender of MIC's Licence as Insurance Web Aggregator. Consequently, MIC ceased to be an Insurance Web Aggregator effective from August 05, 2026.
