Dear Sir/ Ma'am,

We refer to our disclosure dated January 27, 2020 vide which we had informed about a Show Cause Notice issued by the Securities and Exchange Board of India ("SEBI"), alleging non-compliance with Regulation 30 of the SEBI Listing Regulations, in relation to disclosures concerning certain arrangements entered into in 2009.

We wish to inform you that vide an order dated May 29, 2026, SEBI has disposed of the said adjudication proceedings and concluded that the Company has not violated the provisions of the SEBI Listing Regulations as alleged in the Show Cause Notice and accordingly, no monetary penalty has been imposed on the Company.

The details as required under the SEBI Listing Regulations read with SEBI master circular SEBI/HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, are enclosed herewith as **Annexure I**.
