Pursuant to the approval of the Board of Directors at its meeting held on 13<sup>th</sup> May 2026 and approval of the members of the Company at their Extra-Ordinary General Meeting held on 6<sup>th</sup> June 2026 and pursuant to In-principle approvals granted by BSE Limited and National Stock Exchange of India Limited vide their respective letters dated 24 June 2026 and upon receipt of an amount aggregating to Rs. 99,95,01,888 (Rupees Ninety-Nine Crore Ninety-Five Lakhs One Thousand Eight Hundred Eighty-Eight only) at the rate of Rs. 42.00/- per equity share and unlisted convertible warrants as subscription price, the Share Allotment Committee of the Board of Directors of the Company has considered and approved the Allotment of 2,19,97,664 (Two Crore Nineteen Lakh Ninety-Seven Thousand Six Hundred Sixty-Four) Equity Shares and 72,00,000 (Seventy Two Lakhs) unlisted convertible warrants on preferential basis to non-promoter persons/ entities and Promoters respectively (‘Allottees’) (as per the list enclosed marked as Annexure 1).
