Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") – Further investment in Wholly Owned Subsidiary

The Board of Directors of Exide Industries Limited" ('Company/EIL') at its meeting held 30th January 2026, had inter alia approved the investment of additional funds up to Rs. 1400 crore by way of subscription in its wholly owned subsidiary, "Exide Energy Solutions Limited" (hereinafter referred as 'EESL') towards setting up of green field multi gigawatt Lithium-ion cell manufacturing facility in India, in one or more tranches.

In this connection, we wish to inform you that the Company on 15th July 2026, has invested Rs. 99,99,99,980 (Rupees ninety-nine crore ninety-nine lakh ninety-nine thousand nine hundred and eighty only) by way of subscription in the equity share capital of EESL, on rights basis. With this investment, the total investment made by the Company in EESL stands to Rs. 4,902.23 crore. There is no change in the shareholding percentage of the Company in EESL pursuant to such an acquisition.

Name of the target entity details in brief such as size, turnover etc.	Exide Energy Solutions Limited (EESL), an existing wholly owned subsidiary of Exide Industries Limited (EIL) was incorporated on 24th March 2022 and is engaged in the business of manufacturing & selling lithium-ion battery cells, modules and packs for India's electric vehicle market and stationary applications. Some of the relevant details of EESL are given below: - Paid up equity share capital as on date: Rs. 1,532.78 crore - Net worth as on 31.03.2026: Rs. 3,991.06 crore - Turnover as on 31.03.2026: Rs. 157.56 crore - Loss after Tax for the year ended 31.03.2026: Rs. 248.16 crore As on date, the total investment by Exide Industries Limited in the equity share capital of EESL including share premium stands to Rs. 4,902.23 crore including investment made in erstwhile merged subsidiary Exide Energy Private Limited ('EEPL').

EESL has allotted 2,85,71,428 nos. equity shares of Rs. 10/- each at a premium of Rs. 25/- per share aggregating to Rs. 99,99,99,980/- (Rupees ninety-nine crore ninety-nine lakh ninety-nine thousand nine hundred and eighty only) on rights basis to EIL. Save & except what is mentioned above, the Promoter/promoter group/group companies have no interest in the transaction. The said transaction is at arm's length.
