O R D E R

We have heard the learned Senior Counsel appearing for the petitioner, and the respondent.

Though we find force in the submissions made by the learned Senior Counsel Mr. Gaurav Agrawal that as a matter of course, Courts shall not prevent the investigation from going on, the fact remains that the matter has been fixed for final hearing on 26<sup>th</sup> May, 2026.

Only on that premise, we are not inclined to interfere with the impugned order except by requesting the High Court to make an endeavour to dispose of the main matter i.e. CRM-M-No.1887/2026, and CRM-M-14561/2026 on or before 15.06.2026.

The Special Leave Petitions stand disposed of, accordingly.

Needless to state, the parties are expected to cooperate with the High Court, especially when it has deemed it appropriate to fix the matters for final hearing on 26<sup>th</sup> May, 2026.
