A W A R D

1. We have heard Dr. Alakh Alok Srivastava, learned counsel appearing for the petitioner, Mr. Partha Sil, learned counsel appearing for the contesting respondent-UCO Bank and also interacted with the petitioner-Mr.Amitava Ghosh.

2. The parties have arrived at an amicable settlement in the terms that the respondent-UCO Bank will pay a consolidated sum of Rs.18,00,000/- (Rupees Eighteen Lakh)

to the petitioner as a full and final settlement amount. The petitioner who was on video conference, also expressed his willingness to the said offer.

3. In view of the above, we direct the respondent-UCO Bank to pay the amount of Rs.18,00,000/- directly to the petitioner within a period of thirty days from today subject to the petitioner furnishing Bank Account details with the respondent-UCO Bank.

We record our appreciation for Dr. Alakh Alok Srivastava, learned counsel for the petitioner; Mr. Partha Sil, learned counsel for the respondent-UCO Bank; Mr. Gautam Patra, Chief General Manager, UCO Bank and for the Board for having positively approached the matter and having worked out the settlement.

5. Accordingly, the Civil Appeal stands disposed of as having been settled in the above terms.
