## O R D E R

### **IA(IBC)/210/KOB/2026 in CP(IBC)/33/KOB/2025**

This application has been filed by the Resolution Professional seeking the following reliefs: -

- a. *Allow extension in the CIRP period from 180 days to 270 days - from 31/05/2026 to 28/08/2026 in the CIRP process of Roofco Trading Company Pvt Ltd.*
- b. *Pass any other order or orders that this Hon'ble Tribunal may deem fit and proper in the interest of justice.*

Ld. Counsel, Mr. Krishnan Unni appears virtually for the Applicant/RP and invited the attention of this Adjudicating Authority to the fact that the CIRP period in respect of the Corporate Debtor is due to expire on 30.05.2026 and that a Resolution Plan received from the suspended director is presently under consideration of the Committee of Creditors. He further submitted that additional time is required for negotiations, modification and final evaluation of the Resolution Plan by the CoC and, accordingly, pursuant to a resolution passed by the CoC with the requisite voting share in its 6<sup>th</sup> meeting held on 19.05.2026, sought extension of the CIRP period by a further period of 90 days from 31.05.2026 to 28.08.2026.

In view of the submissions made by the Counsel for the Applicant and on perusal of the records, this Adjudicating Authority is satisfied that sufficient cause has been shown for seeking extension of the Corporate Insolvency Resolution Process. Accordingly, the CIRP period in respect of the Corporate Debtor, which is due to expire on 30.05.2026, is extended by a further period of **90 days from 31.05.2026 to 28.08.2026**.

Accordingly, the application stands **allowed and disposed of**.
