Pursuant to Regulation 30 read with Schedule III to the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI Listing Regulations**") and Regulation 10(c) of the Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021, ("**SEBI SBEB Regulations**"), we hereby inform that the Nomination and Remuneration Committee of Brainbees Solutions Limited (the '**Company**') has yesterday i.e. on September 08, 2026, approved the allotment of total of 2,344 (Two Thousand Three Hundred and Forty Four Only) Equity Shares and transfer of total of 54,749 (Fifty Four Thousand Seven Hundred and Forty Nine Only) Equity Shares of face value of Rs. 2/- each under Brainbees Employees Stock Option Plan 2022 through cash exercise and cashless exercise method, against the exercise of vested Options by eligible employees.
