UPON hearing the counsel the Court made the following  
O R D E R

1. The Special Leave Petition is directed against the impugned order dated 06.05.2026 in an Interim Application being I.A. No.6549 of 2025 in Writ Petition No.729 of 2024, wherein the petitioners prayed for impleadment of the proposed developer as one of the respondents.

2. We have perused the order impugned. *Prima facie*, we are of the

view that the impugned order has recorded the available findings after taking into consideration all the circumstances of the matter.

3. Our attention is invited to the imposition of a cost of Rs.5,00,000/- (Rupees Five Lakhs Only) upon the petitioners while dismissing the said Interim Application.

4. We are of the view that the Interim Application would have been dismissed by imposing exemplary cost does not commensurate with the efforts made by the petitioners. Consequently, while sustaining the order imposing cost, we direct the petitioners to deposit a sum of Rs.25,000/- (Rupees Twenty-five Thousand Only) as has been directed by the High Court.

5. The Special Leave Petition stands disposed of with the above modification.
