UPON hearing the counsel the Court made the following
O R D E R

1. It appears that questioning the share transfer agreement dated 08.04.2010 and allotment of shares in pursuance thereof, two suits were instituted by

the appellant namely O.S. No. 605/2014 and O.S. No. 896/2015. It further appears that plaints of those suits were rejected under Order 7 Rule 11 of the Code of Civil Procedure, 1908. The order rejecting the plaints were subjected to challenge before the High Court. It is not in dispute that the High Court has set aside the order rejecting the plaints.

2. It appears from the submission of the learned counsel for the respondents that a review has been preferred, which is pending.

3. In such circumstances, we deem it appropriate to defer the hearing of this appeal for a period of three months.

4. In the meantime, it shall be open for the respondents to press the review, which is allegedly pending before the High Court.
