O R D E R

1. Heard Mr. Abhishek Puri, learned counsel for the petitioner. Learned counsel prays for four weeks time to file the rejoinder affidavit to the counter affidavit filed by the respondent no.1.

2. Mr. Preshit Surshe, learned counsel entered appearance on behalf of respondent no.3. Respondent no.3 stands served now.

3. Mr. Huzefa Ahmadi, learned counsel for respondent no.1 submits that an amount of Rs.4,09,25,764/- stands deposited in this Court pursuant to the order of 19.06.2026. Learned Senior Counsel prays for that respondent no.1 should be permitted to withdraw that amount after offering adequate security.

4. We direct that on the submission of bank guarantee to the satisfaction of the concerned Registrar (Judicial) of this Court, the said amount lying in deposits along with accrued interest shall be released to respondent no.1.

5. Liberty is granted to complete the pleadings in the meantime.
