1. This miscellaneous application has been filed at the instance of the original appellant praying for the following modification in the final judgment passed by this Court vide order dated 02.12.2025 in Civil Appeal No. 14512 of 2025:

"16. (a) This Hon'ble Court be pleased to correct/clarify/modify/the said Judgment dated 02.12.2025 passed in Civil Appeal No. 14512 of 2025 by substituting or correcting words "admeasuring 2700 sq. mts." with "ad-measuring 2026.50sq. mts. in paragraphs 54(ii), 73, 74 and 77(2); and/or;
(b) Pass such further and other orders as this Hon'ble Court may deem fit in the facts and circumstances of the case."

2. We heard Mr. Shyam Divan, the learned Senior Counsel appearing for Jyoti Builders-original appellant and Mr. Siddharth Dharmadhikari, the learned counsel appearing for the Slum Rehabilitation Authority. Mr. Dharmadhikari makes a statement after due verification and instructions from his client that the correct figure insofar as the area of subject plot is concerned should be 2026.50 square meters instead of 2700 square meters as stated in the original judgment.

3. The necessary correction shall be undertaken in this regard in the main judgment.

4. Accordingly, this miscellaneous application is disposed of in terms of prayer 16(a) of the application.
