UPON hearing the counsel the Court made the following

O R D E R

Diary No.19983/2023 (Item No.188.41)

1. Learned counsel for the petitioners seeks permission to

withdraw the matter.

2. The Special Leave Petition is, accordingly, dismissed as withdrawn.

Rest of the matters

3. This batch of cases, comprising Civil Appeals, Special Leave Petitions, Contempt Petitions, Miscellaneous Applications, Review Petitions, Curative Petition(s), etc. pertains to acquisition of lands in the NCT of Delhi. Despite the large number of such cases decided through three decisions rendered by a Coordinate Bench, of which one of us (Surya Kant, J., as he then was) was a member, i.e., (i) *State (NCT of Delhi) v. K.L. Rathi Steels Ltd.*, (2024) 7 SCC 315, (ii) *State (NCT of Delhi) v. BSK Realtors LLP*, (2024) 7 SCC 370, and, (iii) *DDA v. Tejpal*, (2024) 7 SCC 433, hundreds of cases, i.e., the instant matters, still await adjudication in terms of those decisions.

4. It appears to us that the appropriate recourse would be to remit these cases to the High Court of Delhi, with a request to Hon'ble the Chief Justice of the High Court to constitute a dedicated Division Bench, which shall take up these cases on day-to-day basis. The adjudication therein, it goes without saying, would be strictly in terms of the law laid down in the above-cited judgements.

5. Some of the cases in these batch matters, however, might not be pertain, even tangentially, to the interpretation and application of Section 24 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement

Act, 2013 ("2013 Act"). For example, there might be a case seeking enhancement or reduction in compensation for the acquired land. Such cases would, thus, not come to be disposed of in terms of the three judgments rendered by the Coordinate Bench on 17.05.2024, cited above, and are not intended to be remitted to the High Court.

6. Mr. Sanjay Poddar, learned Senior Counsel representing the DDA in these matters, has handed over a compilation of the categorisation of the pending cases under different heads, including the cases that do not pertain to these issues. He has gracefully agreed to circulate the list and provide a soft copy thereof to all the learned counsel on demand.

7. Upon going through that compilation, if the learned counsel are of the opinion that their case(s) is alien to the issue of interpretation of Section 24 of the 2013 Act, the validity of the acquisition under the Land Acquisition Act, 1894, or has nothing to do with the interplay between the Land Acquisition Act, 1894 and the 2013 Act, he/she shall submit a list of such alien cases, along with a brief note as to why such case(s) is not covered by the above-mentioned judgements, to Mr. Poddar through his assisting counsel. This shall be done on or before 03.08.2026. We may record that, for this purpose, Mr. Poddar is assisted by AORs - Ms. Malvika Kapila (Mobile No. - +919810400283) and Mr. Nitin Mishra (Mobile No. - +919810070377).

8. If such submission is accepted by Mr. Poddar, he may make the necessary changes to the list, else he shall adduce such objections to his compilation. Thereafter, the revised list shall be submitted to the Court by 05.08.2026.

9. Mr. Poddar also points out that many other cases pertaining to the same issues are not listed today, which however pertain to the covered issues and are also liable to be remanded to the High Court. These cases are said to be included in the above-mentioned compilation.

10. Due to the commonality in issues, those cases are taken on board. Mr. Poddar undertakes to inform the learned counsel for the parties in such cases about the passing of this order to enable such counsel to also file their objection, if any, with him.

11. The matters, which after scrutiny of the compilation to be submitted by Mr. Poddar are identified to pertain to issues settled through the three above-cited judgements, stand disposed of and remitted to the High Court through a detailed signed order/judgement of even date. The remaining cases, if any, shall be listed after taking appropriate directions from the Chief Justice of India, on the administrative side.
