I would like to inform that due to my pre-occupation and other professional commitments, I may not be able to devote sufficient time to effectively discharge my duties as an Independent Director of the Company.


Please accept my resignation as an Independent Director on the Board of your Company, with effect from 15<sup>th</sup> May 2026.
